5 AN ORDINANCE CONCERNING A CONTINUATION GRANT;
6 APPROPRIATING \$4,028,009.00 (\$2,948,009.00 IN
7 ANNUAL FEDERAL HOME INVESTMENT PARTNERSHIP
8 (HOME) GRANT PROGRAM FUNDING FROM THE U.S.
9 DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT
10 AND \$1,080,000.00 IN PROGRAM INCOME) TO
11 PROVIDE FUNDING FOR A WIDE RANGE OF
12 ACTIVITIES, INCLUDING BUILDING, BUYING, AND/OR
13 REHABILITATING AFFORDABLE HOUSING FOR RENT OR
14 HOMEOWNERSHIP FOR, OR PROVIDING DIRECT RENTAL
15 ASSISTANCE TO, LOW INCOME INDIVIDUALS AND
16 FAMILIES, AS INITIATED BY B.T. 20-003;
17 APPROVING POSITIONS, AS INITIATED BY R.C. 20-
18 002 PROVIDING FOR AN EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
22 within the City's budget, there is hereby appropriated the
23 indicated sum from the account listed in subsection (a) to the
24 account listed in subsection (b):

26 by this reference):

31 (c) Explanation of Appropriation.

1 The funding above in the amount of \$4,028,009.00 consists
2 of \$2,948,009.00 in annual Federal HOME Investment
3 Partnership (HOME) Grant Program funding from the U.S.
4 Department of Housing and Urban Development, and
5 \$1,080,000.00 in program income. Jurisdictions must match
6 every dollar of HOME funds used (except for
7 administrative costs) with 25 cents from nonfederal
8 sources, which may include donated materials or labor,
9 the value of donated property, proceeds from bond
10 financing, and other resources. The City meets this match
11 requirement by utilizing State Housing Initiative
12 Partnership (SHIP) funds for activities and recipients
13 that are eligible under the HOME program.

14 **Section 2. Purpose.** The purpose of the appropriation in
15 Section 1 is to provide funding for a wide range of activities,
16 including building, buying, and/or rehabilitating affordable
17 housing for rent or homeownership for, or providing direct rental
18 assistance to, low income individuals and families. The Schedule of
19 Proposed Funding detailing the proposed use of funds is attached
20 hereto as **Exhibit 2** and incorporated herein by this reference. A
21 copy of the grant award letter is attached hereto as **Exhibit 3** and
22 incorporated herein by this reference. A copy of the certified
23 minutes excerpt of the March 27, 2019 regular meeting of the
24 Jacksonville Housing and Community Development Commission is
25 attached hereto as **Exhibit 4** and incorporated herein by this
26 reference.

27 **Section 3. Approval of Positions.** There are hereby
28 approved the positions more fully described in Revised R.C. 20-002,
29 attached hereto as **Exhibit 5** and incorporated herein by this
30 reference.
