ORDINANCE APPROPRIATING \$6,449.39 FROM ΑN COUNCIL DISTRICT 13 LOBLOLLY RECREATION/PARKS ACCOUNT TO PROVIDE FUNDING TO THE JACKSONVILLE BEACH ELEMENTARY PRESERVATION FUND, INC. PROVIDE FUNDING FOR IMPROVEMENTS TO THE RHODA CULTURAL HERITAGE CENTER MARTIN JACKSONVILLE BEACH, LOCATED AT 376 4TH STREET SOUTH, JACKSONVILLE BEACH, FL 32250; PROVIDING FOR REVERTER LANGUAGE; FINDING A MUNICIPAL PURPOSE; WAIVING THE REQUIREMENTS OF SECTION 111.780 (LOBLOLLY WETLANDS MITIGATION SPECIAL REVENUE FUND) AND SECTION 106.315 (DISTRICT COUNCIL EXPENDITURES), ORDINANCE CODE, THAT FUNDS BE USED ON CITY PROPERTY AND BE OPEN TO THE PUBLIC; WAIVING COMPLIANCE WITH SECTION 106.315 (DISTRICT COUNCIL EXPENDITURES) AS TO PROCEDURES FOR APPROPRIATION OF DISTRICT COUNCIL FUNDS; WAIVING THE RELEVANT PROVISIONS OF CHAPTER 118 (MISCELLANEOUS APPROPRIATIONS), ORDINANCE CODE, AS TO AUDITING AND COMPLIANCE MEASURES FOR GRANTS FROM THE CITY SINCE THE PROVIDES ADEQUATE COMPLIANCE; CONTRACT AUTHORIZING THE MAYOR OR HIS DESIGNEE AND THE CORPORATE SECRETARY TO EXECUTE A CONTRACT; APPOINTING THE DEPARTMENT OF PARKS, RECREATION, COMMUNITY SERVICES TO OVERSEE THE PROJECT; PROVIDING FOR DIRECT PROCUREMENT OF

CONTRACTUAL SERVICES PURSUANT TO SECTION 126.107(G), ORDINANCE CODE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2018-2019 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above is an appropriation of \$6,449.39 from District 13 Loblolly funds to Subsidies and Contributions to Private Organizations to make improvements to the Rhoda L. Martin Cultural Heritage Center in Jacksonville Beach.

Section 2. Purpose. The purpose of this appropriation is to provide funding to Jacksonville Beach Elementary Preservation Fund, Inc. for improvements (signs, flooring, and painting) to the Rhoda L. Martin Cultural Heritage Center in Jacksonville Beach, located at 376 4th Street South, Jacksonville Beach, FL 32250, as more fully described in Exhibit 2 attached hereto.

Section 3. Finding of Public Purpose. The City finds that the Jacksonville Beach Elementary Preservation Fund, Inc.'s use of City funds to provide improvements to the Rhoda L. Martin Cultural Heritage Center is a valid municipal purpose for which

funds should be expended under the bonds.

Section 4. Reverter. If the property is not improved by September 30, 2020, the Jacksonville Beach Elementary Preservation Fund, Inc. shall return the funds in Section 1 to the City.

Section 5. Waiving the Requirements that funds be used on City Property. The provisions of Sections 111.780 (Loblolly Wetlands Mitigation Special Revenue Fund) and 106.315 (District Council expenditures), Ordinance Code, requiring that the loblolly funds be used on City property for capital improvements to Parks, and open to the public, is hereby waived. The waiver is necessary because the Rhoda L. Martin Cultural Heritage Center is not a park on City property, but is a museum open to the public and is a museum set in a segregation-era elementary school.

Section Section 6. Waiving Compliance with106.315 (District Council Expenditures), Ordinance Code, as to Procedures for Appropriation of District Council Funds. The provisions of Section 106.315, Ordinance Code, and Ordinance 2015-631-E requiring use of funds at City owned properties and specifically City parks are hereby waived as the Rhoda L. Martin Cultural Heritage Center is not located on public land in the city of Jacksonville but is owned by the Jacksonville Beach Elementary Preservation Fund, Inc., a registered 501(c)(3) organization, and located in Jacksonville Beach. The Rhoda L. Martin Cultural Heritage Center operates a museum on the property that is open to the public and free of charge. The provisions of Section 106.315(a), Ordinance Code, requiring the expenditure of funds of less than \$100,000 pursuant to an administrative process as stated therein is hereby waived as the District Council funds are being appropriated directly by this legislation and subject to an agreement with adequate compliance and auditing requirements, attached hereto as Exhibit 3, and so strict compliance with Section 106.315(a) is not necessary.

Waiving the Relevant Provisions of Chapter 118 Section 7. (Miscellaneous Appropriations), Ordinance Code, as to Auditing and Compliance Measures for Grants from the City. Recognizing the amount of the contribution to Jacksonville Beach Elementary Preservation Fund, Inc. (which is less than \$6,500 total) and that the auditing and compliance provisions of Chapter 118 would be cumbersome to the acceptance of a grant of the size herein, and further recognizing that the contract attached hereto as Exhibit 3 provides adequate auditing and compliance requirements for the expenditure of funds (including requiring sufficient evidence of payment for the work, evidence that any contractor liens have been satisfied, a final report detailing how the funds were spent and audit rights for the Council Auditor), the relevant provisions of (Miscellaneous Appropriations), Ordinance 118 concerning grants from the City are hereby waived as adequate

Section 8. Authorizing the execution of the Contract. The Mayor, his designee and Corporation Secretary are hereby authorized to execute the Agreement between the City of Jacksonville and Jacksonville Beach Elementary Preservation Fund, Inc. for improvements to the Rhoda L. Martin Cultural Heritage Center, in substantially the form attached hereto as Exhibit 3, and such insurance provisions as the City of Jacksonville Risk Management Division may provide, and incorporated herein by this reference, for the project described in Section 2.

protection to the City will be afforded by the agreement that will

be executed substantially in the form attached hereto as Exhibit 3.

Section 9. Oversight. The Mayor is requested to appoint the Department of Parks, Recreation, and Community Services to insure compliance with the agreement and all other appropriate laws.

Section 10. Procurement of Contractual Services. The City

is hereby authorized to procure the services of Jacksonville Beach 1 2 Elementary Preservation Fund, Inc. to purchase the equipment and 3 material specified in **Exhibit 2**. Pursuant to Section 126.107(g), Ordinance Code, such procurement is exempt from competitive 4 solicitation. With the exception of the foregoing, all other 5 provisions of Chapter 126, Ordinance Code, shall remain in full 6 force and effect. Section 11.
