This BT is to appropriate proceeds from the sale of Water Quality Compensatory Credits pursuant to Ord. 2017-0516-E. The City is the owner of the St. Johns River Water Management District Permit No. 18269-1 (the City Stormwater Permit) which is applicable to the City's downtown area. The City Stormwater Permit has surplus stormwater facility compensatory credits that may be used to meet the water quality requirements of future downtown development projects. Water Compensatory Credits have been sold or used as credits to incentivize downtown development projects as an alternative to meeting the stormwater facility water quality requirements. This action is to appropriate the proceeds from these sales for the purpose of performing drainage system rehabilitation work in the downtown area as defined by Section 55.105, Ordinance Code. Deferral of this amendment of the CIP until the next annual budget and CIP review will be detrimental to the best interest of the community because such deferral will result in the unnecessary delay of needed drainage system rehabilitation work in the downtown area.






