5 AN ORDINANCE APPROVING THE ISLE OF PALMS
6 DEPENDENT SPECIAL DISTRICT AMENDED FISCAL YEAR
7 2019/2020 BUDGET, PER ORDINANCE 2011-724-E AND
8 SECTION 189.02, *FLORIDA STATUTES*; PROVIDING AN
9 EFFECTIVE DATE.

11 **WHEREAS**, the City of Jacksonville established the Isle of
12 Palms Dependent Special District (the "District"), per Ordinance
13 2011-724-E and section 189.02, *Florida Statutes*, a dependent
14 special district for the purpose of dredging the Isle of Palms
15 canal system; and

16 **WHEREAS**, in order for the District to qualify as a dependent
17 special district per section 189.02, *Florida Statutes*, the City, in
18 Ordinance 2011-724-E, required the District to submit its proposed
19 budget to the City Council every year by April 1st; and

20 **WHEREAS**, the District submitted its proposed Fiscal Year
21 2019/2020 budget, which was approved by the City Council in
22 Ordinance 2019-207-E, that set the non-ad valorem assessment per
23 parcel at \$850.00; and

24 **WHEREAS**, on August 14, 2019, the District adopted Resolution
25 19-04 which increased the non-ad valorem assessment to be levied on
26 property from \$850.00 per parcel to \$950.00 per parcel; and

27 **WHEREAS**, the Isle of Palms Special District has submitted the
28 amended Fiscal Year 2019/2020 budget to the City Council for
29 approval pursuant to Ordinance 2011-724-E, a copy of the Board

1 Resolution is attached hereto as **Exhibit 1**; and

2 **WHEREAS**, the City Council finds that the Isle of Palms Special
3 District amended Fiscal Year 2019/2020 budget in **Exhibit 1** should
4 be approved; now therefore

5 **BE IT ORDAINED** by the Council of the City of Jacksonville:

6 **Section 1. Approval of Isle of Palms Dependent Special**
7 **District Amended Fiscal Year 2019/2020 Budget.** The Isle of Palms
8 Dependent Special District amended Fiscal Year 2019/2020 budget,
9 attached hereto as **Exhibit 1**, is hereby approved.

10 **Section 2. Effective Date.** This ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
