through the millage rate and expend public funds through a budgetary process, a budget which is currently \$1.8 billion of tax payers funds; and

BE IT RESOLVED by the Council of the City of Jacksonville:

section 1. Opposing Local Bill J-1. The Council hereby expresses its opposition for Local Bill J-1, to be considered by the Duval County Legislative Delegation, for the 2020 State Legislative Session. Said Local Bill J-1 would amend Chapter 92-341, Laws of Florida, and Section 13.01, Charter of the City of Jacksonville, to provide that members of the Duval County School board be appointed by the mayor of the city of Jacksonville. A true and correct copy of said Local Bill J-1 is attached hereto as Exhibit 1.
