7 AN ORDINANCE APPROPRIATING \$95,000.00 FROM  
8 NORTHWEST JACKSONVILLE ECONOMIC DEVELOPMENT -  
9 RESERVES TO THE NORTHWEST JACKSONVILLE  
10 ECONOMIC DEVELOPMENT - SUBSIDIES AND  
11 CONTRIBUTIONS TO ALLOW THE CITY TO PARTNER  
12 WITH JTA TO FUND A GRANT FOR A PILOT  
13 TRANSPORTATION PROGRAM APPROVED BY ORDINANCE  
14 2019-245-E ENTITLED "FULL SERVICE GROCERY  
15 STORE IMPROVEMENT PROGRAM" (THE "PROGRAM") FOR  
16 ONE YEAR, AS INITIATED BY B.T. 20-024;  
17 APPROVING AND AUTHORIZING THE MAYOR, OR HIS  
18 DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE  
19 AND DELIVER, FOR AND ON BEHALF OF THE CITY,  
20 THE FUNDING AGREEMENT BETWEEN THE CITY OF  
21 JACKSONVILLE AND THE JACKSONVILLE  
22 TRANSPORTATION AUTHORITY FOR PILOT  
23 TRANSPORTATION PROGRAM; PROVIDING FOR CITY  
24 OVERSIGHT BY THE OFFICE OF ECONOMIC  
25 DEVELOPMENT; PROVIDING AN EFFECTIVE DATE.

27 **BE IT ORDAINED** by the Council of the City of Jacksonville:

28 **Section 1. Appropriation.** For the 2019-2020 fiscal year,  
29 within the City's budget, there are hereby appropriated the  
30 indicated sum(s) from the account(s) listed in subsection (a) to  
31 the account(s) listed in subsection (b):

7 (c) Explanation of Appropriation

8 The funding above is a transfer of funds from Northwest  
9 Jacksonville Economic Development - Reserves to Northwest  
10 Jacksonville Economic Development - Subsidies and  
11 Contributions to fund a grant to the Jacksonville  
12 Transportation Authority (JTA) for a one-year pilot  
13 transportation program.

14 **Section 2. Purpose.** The purpose of the appropriation in  
15 Section 1 is to allow the City to partner with JTA to fund a grant  
16 for a pilot transportation program approved by Ordinance 2019-245-E  
17 entitled "Full Service Grocery Store Improvement Program" (the  
18 "Program") for one year. The Program will make convenient and  
19 reliable transportation to grocery stores available to residents of  
20 the Northwest Jacksonville Economic Development Area (the "Area")  
21 and incentivize the operation of new supermarkets and healthy food  
22 programs within the Area.

23 **Section 3. Approval and authorization.** There is hereby  
24 approved, and the Mayor, or his designee, and the Corporation  
25 Secretary are hereby authorized to execute and deliver, for and on  
26 behalf of the City, the Funding Agreement between the City of  
27 Jacksonville and the Jacksonville Transportation Authority for  
28 Pilot Transportation Program, attached hereto as **Exhibit 2** and  
29 incorporated herein by this reference.

30 **Section 4. Oversight Department.** The Office of Economic  
31 Development shall oversee the project described herein.

1           **Section 5.           Effective Date.**   This ordinance shall become  
2 effective upon signature by the Mayor or upon becoming effective  
3 without the Mayor's signature.
