7 **ORDINANCE 2019-763-E**

8 AN ORDINANCE APPROPRIATING \$250,000.00 FROM
9 GENERAL FUND/GENERAL SERVICES DISTRICT FUND
10 BALANCE TO FACILITATE SETTING UP OFFICE SPACES
11 AND EQUIPMENT IN THE EXISTING PARKS,
12 RECREATION AND COMMUNITY SERVICES DEPARTMENT
13 LOCATION FOR THE NEWLY CREATED SPORTS AND
14 ENTERTAINMENT DIVISION, AS INITIATED BY
15 REVISED B.T. 20-020; REQUESTING ONE CYCLE
16 EMERGENCY PASSAGE; PROVIDING FOR AN EFFECTIVE
17 DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
21 within the City's budget, there is hereby appropriated the
22 indicated sum from the account(s) listed in subsection (a) to the
23 account(s) listed in subsection (b):

25 as "Revised Exhibit 1, Revised B.T. 20-020, November 4, 2019 -
26 NCSPHS" and incorporated herein by this reference):

1 (c) Explanation of Appropriation

2 The appropriation above is from General Fund/General Services
3 District Fund Balance and is being appropriated to the Office
4 of Sports & Entertainment for furniture and equipment, and
5 professional services.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to facilitate setting up office spaces and equipment
8 in the existing Parks, Recreation and Community Services Department
9 (the "Department") location for the Sports and Entertainment
10 Division (the "Division"). Pursuant to Ordinance 2019-395-E, the
11 Sports and Entertainment Office was moved into the Department,
12 creating a Sports and Entertainment division responsible for sports
13 and entertainment activities within the City of Jacksonville,
14 including but not limited to identifying sports and entertainment
15 opportunities, benchmarking and assessment of opportunities,
16 ensuring the development of a program design, relationship
17 management, identification of funding mechanisms to support the
18 events, and the tracking of value created through sports and
19 entertainment opportunities. The Division will also be responsible
20 for overseeing the Sports and Entertainment Trust Fund and
21 operating the Office of Special Events.

22 **Section 3. Requesting one cycle emergency passage**
23 **pursuant to Council Rules 4.901 Emergency.** One cycle emergency
24 passage of this legislation is requested. The nature of the
25 emergency is the need to relocate the Sports and Entertainment
26 Division so that it will be better able to assist with Department
27 efficiency and outcomes.

28 **Section 4. Effective Date.** This ordinance shall become
29 effective upon signature by the Mayor or upon becoming effective
30 without the Mayor's signature.
