5 AN ORDINANCE APPROVING AND AUTHORIZING THE  
6 MAYOR AND CORPORATION SECRETARY TO EXECUTE AND  
7 DELIVER A DEVELOPMENT AGREEMENT BETWEEN THE  
8 CITY OF JACKSONVILLE AND SAWMILL TIMBER, LLC  
9 (OWNER), INCLUDING ACCEPTANCE OF DEEDS OF  
10 DEDICATION RELATING THERETO, CONCERNING A  
11 DEVELOPMENT KNOWN AS 9A JTB BAYMEADOWS TMA  
12 SECTOR A-SOUTHEAST QUADRANT TMA ROAD PH. 1 (A-  
13 3), APPLICATION NO. 20993.0/CDN 4553.169, FOR  
14 DEDICATION OF RIGHT-OF-WAY TO THE CITY OF  
15 JACKSONVILLE FOR FUTURE ROAD CONSTRUCTION BY  
16 THE OWNER OR ITS ASSIGNEE, PURSUANT TO SECTION  
17 163.3220, ET SEQ., *FLORIDA STATUTES*, AND PART  
18 2, CHAPTER 655, *ORDINANCE CODE*; PROVIDING AN  
19 EFFECTIVE DATE.

21 **WHEREAS**, Section 163.3220, et seq., *Florida Statutes*, and Part  
22 2, Chapter 655, *Ordinance Code*, authorize Development Agreements,  
23 subject to the procedures and requirements set forth therein; and

24 **WHEREAS**, the Planning and Development Department has  
25 recommended approval of the Development Agreement between the City  
26 of Jacksonville and Sawmill Timber, LLC (Owner), concerning a  
27 development known as 9A JTB Baymeadows TMA Sector A-Southeast  
28 Quadrant TMA Road Ph. 1 (A-3), Application No. 20993.0/CDN  
29 4553.169, for dedication of right-of-way to the City of  
30 Jacksonville for future road construction by the Owner, or its  
31 assignee; and

1           **WHEREAS**, all notice and public hearing requirements have been  
2 met, pursuant to Section 163.3225, *Florida Statutes*, and Section  
3 655.206, *Ordinance Code*; now, therefore

4           **BE IT ORDAINED** by the Council of the City of Jacksonville:

5           **Section 1.           Approval of Development Agreement.**       The  
6 Development Agreement between the City of Jacksonville and Sawmill  
7 Timber, LLC, is hereby approved in substantially the same form as  
8 **Exhibit 1, attached hereto.** The Mayor and Corporation Secretary are  
9 authorized to execute said Agreement on behalf of the City, and  
10 accept the deeds of dedication for the right-of-way as provided  
11 therein.

12           **Section 2.           Effective Date.** This Ordinance shall become  
13 effective upon the signature by the Mayor or upon becoming  
14 effective without the Mayor's Signature.
