5 AN ORDINANCE CLOSING AND ABANDONING AND/OR  
6 DISCLAIMING VARIOUS UNOPENED AND UNIMPROVED  
7 RIGHTS-OF-WAY ESTABLISHED IN PLAT BOOK 6, PAGE  
8 29 OF THE PUBLIC RECORDS OF DUVAL COUNTY, IN  
9 COUNCIL DISTRICT 2, AT THE REQUEST OF CORNER  
10 LOT DEVELOPMENT GROUP, LLC; PROVIDING FOR  
11 APPROVAL SUBJECT TO CONDITIONS; PROVIDING AN  
12 EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Closure and Abandonment.** Various unopened and  
16 unimproved rights-of-way established in Plat Book 6, Page 29 of the  
17 Public Records of Duval County, in Council District 2, descriptions  
18 of which are attached hereto as **Exhibit 1** and incorporated herein  
19 by this reference, is hereby closed and abandoned and/or disclaimed  
20 as a right-of-way at the request of Corner Lot Development Group,  
21 LLC (the "Applicant"). This request is contingent upon the pending  
22 approval of the Florida Department of Transportation; otherwise,  
23 there are no city, state, or other agency objections to this  
24 closure request. Applicant has paid the right-of-way closure  
25 application fees of \$8,364.00, and this amount has been deposited  
26 into the General Fund, PWRE011-34907.

27 **Section 2. Purpose.** The Applicant is requesting the  
28 closure of the rights-of-way to accommodate the proposed plat of a  
29 single-family residential neighborhood for a single-family  
30 residential community containing 50 lots.

31 **Section 3. Hold Harmless Covenant.** The closure and

1 abandonment by the City of its interests in the rights-of-way is  
2 subject to the execution and delivery to the City by Applicant  
3 ("Grantor") of a hold harmless covenant in substantially the same  
4 form attached hereto as **Exhibit 2** and incorporated herein by this  
5 reference. Accordingly, the closure and abandonment of the rights-  
6 of-way shall not be recorded in the Public Records until execution  
7 and delivery to the City by Grantor of the required hold harmless  
8 covenant.

9 **Section 4. Effective Date.** This ordinance shall become  
10 effective upon signature by the Mayor or upon becoming effective  
11 without the Mayor's signature.
