ORDINANCE 2019-869

AN ORDINANCE ADOPTING A SMALL-SCALE AMENDMENT TO THE FUTURE LAND USE MAP SERIES OF THE 2030 COMPREHENSIVE PLAN BY CHANGING THE FUTURE LAND USE DESIGNATION FROM LOW DENSITY RESIDENTIAL (LDR) TO LOW DENSITY RESIDENTIAL (LDR) WITH SITE SPECIFIC FLUE POLICY 4.4.14 ON APPROXIMATELY 9.11± ACRES LOCATED IN COUNCIL DISTRICT 14 AT 5236 110^{TH} STREET AND 5250 110^{TH} STREET, BETWEEN CATOMA STREET AND ORTEGA FARMS BOULEVARD, OWNED BY PATRIOT'S LANDING, INC., AS MORE PARTICULARLY DESCRIBED HEREIN, PURSUANT TO APPLICATION NUMBER L-5416-19C AND A COMPANION SETTLEMENT AGREEMENT; ADOPTING A SITE SPECIFIC POLICY/TEXT AMENDMENT DIRECTLY RELATED TO THIS MAP AMENDMENT; PROVIDING A DISCLAIMER THAT THE AMENDMENT GRANTED HEREIN SHALL NOT BE CONSTRUED AS AN EXEMPTION FROM ANY OTHER APPLICABLE LAWS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to the provisions of Section 650.402(b), Ordinance Code, and Section 163.3187(1), Florida Statutes, application for a proposed Small-Scale Amendment to the Future Land Use Map series (FLUMs) of the 2030 Comprehensive Plan to change the Future Land Use designation from Low Density Residential (LDR) to Low Density Residential (LDR) with Site Specific FLUE Policy 4.4.14 on 9.11± acres of certain real property in Council District 14, was filed by the City of Jacksonville, on behalf of the owner,

Patriot's Landing, Inc., pursuant to the Settlement Agreement approved by companion Ordinance 2019-868; and

WHEREAS, the Planning and Development Department reviewed the proposed revision and application and has prepared a written report and rendered an advisory recommendation to the City Council with respect to the proposed amendment; and

WHEREAS, the Planning Commission, acting as the Local Planning Agency (LPA), held a public hearing on this proposed amendment, with due public notice having been provided, reviewed and considered comments received during the public hearing and made its recommendation to the City Council; and

WHEREAS, the Land Use and Zoning (LUZ) Committee of the City Council held a public hearing on this proposed amendment to the 2030 Comprehensive Plan, pursuant to Chapter 650, Part 4, Ordinance Code, considered all written and oral comments received during the public hearing, and has made its recommendation to the City Council; and

WHEREAS, the City Council held a public hearing on this proposed amendment, with public notice having been provided, pursuant to Section 163.3187, Florida Statutes and Chapter 650, Part 4, Ordinance Code, and considered all oral and written comments received during public hearings, including the data and analysis portions of this proposed amendment to the 2030 Comprehensive Plan and the recommendations of the Planning and Development Department, the Planning Commission and the LUZ Committee; and

WHEREAS, in the exercise of its authority, the City Council has determined it necessary and desirable to adopt this proposed amendment to the 2030 Comprehensive Plan to preserve and enhance present advantages, encourage the most appropriate use of land, water, and resources consistent with the public interest, overcome

present deficiencies, and deal effectively with future problems which may result from the use and development of land within the City of Jacksonville; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Purpose and Intent. This Ordinance is adopted to carry out the purpose and intent of, and exercise the authority set out in, the Community Planning Act, Sections 163.3161 through 163.3248, Florida Statutes, and Chapter 166, Florida Statutes, as amended.

Section 2. Subject Property Location and Description. The approximately 9.11± acres (R.E. Nos. 103350-0000 and 103351-0000) are located in Council District 14 at 5236 110th Street and 5250 110th Street, between Catoma Street and Ortega Farms Boulevard, as more particularly described in Exhibit 1, dated November 14, 2019, and graphically depicted in Exhibit 2, both attached hereto and incorporated herein by this reference (Subject Property).

Section 3. Owner and Applicant Description. The subject property is owned by Patriot's Landing, Inc. The applicant is the City of Jacksonville, 214 North Hogan Street, Suite 300, Jacksonville, Florida 32202; (904) 255-7800.

Section 4. Adoption of Small-Scale Land Use Amendment. The City Council hereby adopts a proposed Small-Scale revision to the Future Land Use Map series of the 2030 Comprehensive Plan by changing the Future Land Use Map designation from Low Density Residential (LDR) to Low Density Residential (LDR) with Site Specific FLUE Policy 4.4.14, pursuant to Application Number L-5416-19C and the Settlement Agreement approved by companion Ordinance 2019-868.

Section 5. Site Specific Policy/Text Amendment. The following site specific policy/text amendment shall be applicable to the Subject Property:

Future Land Use Element (FLUE), Policy 4.4.14

Pursuant to the authority granted by Sec. 163.3187(1)(c), Florida Statutes, Ordinance 2019-869 for a Small-Scale Amendment is approved subject to the following site specific conditions:

- 1. Pursuant to a Settlement Agreement between the City of Jacksonville and Patriot's Landing, Inc., dated _______, the total coverage by all buildings and structures within the Subdivision shall not exceed twenty percent of the total area of the Subdivision (the "20% Coverage Restriction"). By way of example and not limitation, if the total area of the Subdivision is 9.11 acres, the total coverage by all buildings and structures within the Subdivision shall not exceed 79,366.32 square feet of land area (9.11 x 43,560 x 0.2).
- 2. Development shall be exempt from the APZ 2/II density limitations established within the Future Land Use Element, and the directly related implementing land development regulations.
- Section 6. Applicability, Effect and Legal Status. The applicability and effect of the 2030 Comprehensive Plan, as herein amended, shall be as provided in the Community Planning Act, Sections 163.3161 through 163.3248, Florida Statutes, and this Ordinance. All development undertaken by, and all actions taken in regard to development orders by governmental agencies in regard to land which is subject to the 2030 Comprehensive Plan, as herein amended, shall be consistent therewith as of the effective date of this amendment to the plan.

Section 7. Effective date of this Plan Amendment.

- (a) If the amendment meets the criteria of Section 163.3187, Florida Statutes, as amended, and is not challenged, the effective date of this plan amendment shall be thirty-one (31) days after adoption.
 - (b) If challenged within thirty (30) days after adoption, the

plan amendment shall not become effective until the state land planning agency or the Administration Commission, respectively, issues a final order determining the adopted Small-Scale Amendment to be in compliance.

(c) Notwithstanding the above, this plan amendment will not be effective until the Settlement Agreement approved by Ordinance 2019-XXX is executed by all parties.

Section 8. Disclaimer. The amendment granted herein shall not be construed as an exemption from any other applicable local, state, or federal laws, regulations, requirements, permits or approvals. All other applicable local, state or federal permits or approvals shall be obtained before commencement of the development issuance of this use and amendment is based acknowledgement, representation and confirmation made applicant(s), owner(s), developer(s) and/or any authorized agent(s) or designee(s) that the subject business, development and/or use will be operated in strict compliance with all laws. Issuance of this amendment does **not** approve, promote or condone any practice or act that is prohibited or restricted by any federal, state or local laws.

Section 9. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
