## ORDINANCE 2019-884

AN ORDINANCE APPROVING AND AUTHORIZING THE TRANSFER FROM SUNSHINE RECYCLING, INC. TO WCA OF FLORIDA, LLC OF ITS NON-RESIDENTIAL SOLID WASTE COLLECTION AND TRANSPORTATION FRANCHISE PURSUANT TO SECTION 380.609, *ORDINANCE CODE*; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution 2004-663-A, Sunshine Recycling, Inc. was granted a non-residential solid waste collection and transportation franchise (the "Franchise"); and

WHEREAS, WCA of Florida, LLC ("WCA") has filed an application for the transfer of the Franchise from Sunshine Recycling, Inc. to WCA; and

18 WHEREAS, the transfer of the Franchise will allow the existing 19 franchise operator continued growth through a new corporate entity 20 that has the financial stability and access to greater levels of 21 capital to sustain that growth; and

WHEREAS, WCA has certified that it is financially fit and has sufficient experience in the solid waste collection and transportation business to adequately perform all of Sunshine Recycling, Inc.'s liabilities, obligations, conditions, and standards under the Franchise; and

WHEREAS, WCA has certified that it has the means to provide sufficient equipment and facilities to adequately perform all of Sunshine Recycling, Inc.'s liabilities, obligations, conditions, and standards under the Franchise; and

WHEREAS, the Department of Public Works recommends that WCA's

application for the transfer of the Franchise from Sunshine
Recycling, Inc. to WCA be granted; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Transfer of Franchise authorized. 4 In 5 accordance with the provisions of Chapter 380 (Solid Waste Management), Part 6 (Nonresidential Solid Waste Collection and 6 7 Transportation Franchises), Ordinance Code, the Director of the Department of Public Works is hereby authorized to transfer the 8 Franchise from Sunshine Recycling, Inc. to WCA. WCA shall be bound 9 10 by the information provided in the application for transfer, which 11 information is **on file** with the Legislative Services Division and 12 by this reference incorporated herein. A copy of the Non-13 Residential Solid Waste Collection and Transportation Franchise 14 Agreement is attached hereto as **Exhibit 1**.

15 Section 2. Effective Date. This ordinance shall become 16 effective upon signature by the Mayor or upon becoming effective 17 without the Mayor's signature.
