AN ORDINANCE CLOSING AND ABANDONING AND/OR JACKSONVILLE DISCLAIMING VARIOUS HEIGHTS UNIMPROVED UNOPENED AND RIGHTS-OF-WAY ESTABLISHED IN PLAT BOOK 5, PAGE 93 OF THE PUBLIC RECORDS OF DUVAL COUNTY, IN COUNCIL DISTRICT 12, ΑT THE REQUEST OF HOME JACKSONVILLE, LLC; PROVIDING FOR APPROVAL SUBJECT TO CONDITIONS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Recipin 1. Closure and Abandonment. Various Jacksonville Heights unopened and unimproved rights-of-way established in Plat Book 5, Page 93 of the Public Records of Duval County, in Council District 12, descriptions of which are attached hereto as Exhibit 1 and incorporated herein by this reference, are hereby closed and abandoned and/or disclaimed as rights-of-way at the request of KB Home Jacksonville, LLC (the "Applicant"). There are no city, state, or other agency objections to this closure request. The Applicant is seeking the closures on behalf of the owners of the properties on both sides of the rights-of-way. Applicant has paid the associated right-of-way closure application fees of \$8,364.00, and this amount has been deposited into the General Fund, PWRE011-34907.

Section 2. Purpose. Applicant is requesting the closure of these rights-of-way to accommodate the proposed plat of a

single-family residential neighborhood. There is no infrastructure within these rights-of-way.

Section 3. Hold Harmless Covenant. The closure and abandonment by the City of its interests in the various rights-of-way is subject to the execution and delivery to the City by Applicant ("Grantor") of a hold harmless covenant in substantially the same form attached hereto as Exhibit 2 and incorporated herein by this reference. Accordingly, the closure and abandonment of the rights-of-way shall not be recorded in the Public Records until execution and delivery to the City by Grantor of the required hold harmless covenant.

Section 4. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
