Type of Action: Appropriation of funds; amending the Ordinance Code; authorizing Administration to execute agreement; providing oversight; waiving bond fund requirement

Bill Summary: The bill appropriates funds in the sum of \$50,000.00 for the design of a mural, purchase of materials and installation of a mural, including lighting, and maintenance costs associated with the project entitled "Roosevelt/Edgewood Artwork & Lighting" project. The transfer of these funds is as follows:

The bill amends Section 126.901 (Definitions), Part 9 (Art in Public Places), Chapter 126 (Procurement Code), of the Ordinance Code to add additional language to the definition for "Public Facility" to include the phrase "...any City-owned or controlled building". The bill authorizes the Administration to execute an agreement for the project. The Mayor is requested to appoint the Public Works Department to oversee the Cultural Council of Greater Jacksonville, Inc., who will be the project manager responsible for the implementation and maintenance of the Project. The bill waives the bond fund requirement stating that bond funds be used on City property, and open to the public since the property is owned by the Florida Department of Transportation.

Background Information: The City finds that the contribution of Autumn Bond (ETR Bonds, Series 2004) discretionary funds to support public art, specifically by funding a lighting and art project on the Roosevelt Boulevard Overpass, a public thoroughfare, accomplishes a public benefit by providing the public with access to an aesthetic visual art feature and is a valid public purpose and in the best interests of the City.
