A RESOLUTION HONORING AND COMMEMORATING THE LIFE AND OUTSTANDING CIVIC ACCOMPLISHMENTS OF FORMER CITY COUNCIL MEMBER AND MAYOR JAKE M. GODBOLD; PROVIDING AN EFFECTIVE DATE.

WHEREAS, lifelong Jacksonville resident Jake Godbold was raised in very humble circumstances in public housing in Jacksonville's Brentwood neighborhood, graduated from Andrew Jackson High School, served in the U.S. Army, sold insurance doorto-door, and for many years owned a janitorial supply company. As a civic-minded activist he was President of the Jaycees, President of Big Brothers and the Boys Club, and Chairman of the Muscular Dystrophy campaign; and

WHEREAS, Mr. Godbold, who was always a civic booster and believed in the power of the city government to improve the lives of the average citizen, was elected to the first Consolidated City of Jacksonville City Council in 1967 and re-elected in 1971 and 1975. He was elected Council President by his peers in 1978 and held that position when then-Mayor Hans Tanzler resigned from office to become a candidate for Governor, whereupon, by virtue of the City Charter, he became Mayor; and

WHEREAS, Mayor Godbold's two terms in office were characterized by boundless boosterism and an unflagging determination to raise Jacksonville's stature and put his home town

on the map as a great city. He presided over a "billion dollar decade" in which the city built the Southbank Riverwalk, converted Jacksonville's former rail terminal into the Prime Osborn Convention Center, and constructed the Jacksonville Landing while numerous private businesses relocated to Jacksonville and built their own buildings throughout the city; and

WHEREAS, one of the signature accomplishments of his term in office was the night in 1979 when "Colts Fever" brought 55,000 football fans to the Gator Bowl to greet then-Baltimore Colts owner Robert Irsay in a show of Jacksonville's passion to acquire an NFL team, a dream that was realized more than a decade later with the decision by the NFL to award the city the Jacksonville Jaguars as an expansion franchise; and

WHEREAS, Jake Godbold was, first and foremost, a man of and for the common people, who represented their best interests in City Hall and beyond. He was fearless in speaking his mind on any and all subjects, regardless of the potential risks, and came out of controversies stronger than ever because of his reputation for absolute honesty and forthrightness. In the decades since he left office his counsel was sought by countless political and business leaders, and his friendship and helpful concern was enjoyed by tens of thousands of his friends and former constituents; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City of Jacksonville hereby honors and commemorates the life and outstanding civic accomplishments of former City Council member, City Council President and Mayor Jake Godbold. His love for the City and the citizens of Jacksonville was unparalleled, and he was truly one of the giant figures in Jacksonville's history. His legacy will be long and gratefully remembered by generations of Jacksonville citizens, and the City Council extends to his family and countless friends and admirers

its sincere condolences.

Section 2. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
