AN ORDINANCE AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY THE FIFTH AMENDMENT TO THE MANAGEMENT SERVICES AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND CECIL FIELD GOLF COURSE, LLC, WHICH: EXTENDS THE TERM OF THE AGREEMENT FOR FIVE ADDITIONAL YEARS; (2) ELIMINATES THE BASE FEE AND PERCENTAGE OF GROSS REVENUES PAYABLE TO THE CITY IN 2020; (3) REVISES THE PAYMENT PERCENTAGE OF SCHEDULE AND GROSS GOING FORWARD; (4) DELETES EXISTING INSURANCE AND INDEMNIFICATION LANGUAGE AND REPLACES IT NEW INSURANCE AND INDEMNIFICATION WITH LANGUAGE; AND (5) UPDATES APPLICABLE PROVISIONS REGARDING PUBLIC RECORDS LAWS; PROVIDING FOR OVERSIGHT ΒY THE RECREATION AND COMMUNITY SERVICES DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City and Meadowbrook Golf Group, Inc., a Delaware corporation ("Meadowbrook") entered into that certain Management Services Agreement dated October 4, 1999 (the "Agreement") for Cecil Field Golf Course (the "Golf Course"); and

WHEREAS, Meadowbrook, as authorized by Resolution 2005-156-A, assigned the Agreement to Capstone Golf, LLC, a Florida limited

liability company ("Capstone") pursuant to an Assignment of Management Services dated May 31, 2005; and

WHEREAS, Capstone, as authorized by Ordinance 2011-499-E, assigned the Agreement to Fiddler's Green Golf Course, LLC a Florida limited liability company, pursuant to an Assignment of Management Services dated September 20, 2011; and

WHEREAS, Fiddler's Green Golf Course, LLC, as authorized by Ordinance 2014-610-E, assigned the Agreement to Cecil Field Golf Course, LLC, a Florida limited liability company, pursuant to an Assignment of Management Services dated August 29, 2014; and

WHEREAS, Cecil Field Golf Course, LLC and City desire to amend the Agreement as set forth in the Fifth Amendment to Management Services Agreement attached hereto as Exhibit 1; now therefore,

BE IT ORDAINED by the Council of the City of Jacksonville:

Authorization to Execute Fifth Amendment to Section 1. Management Services Agreement. The Mayor, or his designee, and the Corporation Secretary, are hereby authorized to execute and deliver, for and on behalf of the City the fifth Amendment to the Management Services Agreement between the City of Jacksonville and Cecil Field Golf Course, LLC, in substantially the same form as is attached hereto as Exhibit 1 and incorporated herein by this reference, which extends the term of the agreement for additional five years, revises the payment fee schedule percentage of gross revenues payable, deletes existing insurance and indemnification language and replaces it with new insurance and indemnification language, and updates provisions regarding public records laws.

Section 2. Departmental oversight. The Parks, Recreation and Community Services Department shall oversee the agreement described herein.

Section 3. Effective Date. This ordinance shall become
