5 **ORDINANCE 2020-115**

6 AN ORDINANCE APPROPRIATING \$35,000.00 FROM A
7 CITY COUNCIL OPERATING CONTINGENCY TO THE
8 JACKSONVILLE HISTORICAL SOCIETY, INC. TO BE
9 USED FOR RENOVATIONS TO THE FLORIDA CASKET
10 COMPANY BUILDING, LOCATED AT 314 PALMETTO
11 STREET, JACKSONVILLE, FLORIDA 32202; PROVIDING
12 FOR A CARRYOVER OF FUNDS INTO THE 2020-2021
13 FISCAL YEAR; APPROVING AND AUTHORIZING
14 EXECUTION OF AGREEMENT BY THE MAYOR OR HIS
15 DESIGNEE AND CORPORATION SECRETARY; INVOKING
16 THE EXCEPTION TO SECTION 126.107(G), *ORDINANCE*
17 *CODE*, IN ORDER TO DIRECT CONTRACT WITH THE
18 JACKSONVILLE HISTORICAL SOCIETY, INC.;
19 PROVIDING FOR WAIVER OF SECTION 118.201(F)(7)
20 (RELEASE OF APPROPRIATIONS), *ORDINANCE CODE*, IN
21 ORDER TO ALLOW UPFRONT PAYMENTS TO JACKSONVILLE
22 HISTORICAL SOCIETY, INC. WITH AN ALLOWANCE FOR
23 A REASONABLE RETAINER; PROVIDING FOR CITY
24 OVERSIGHT BY THE OFFICE OF GRANTS AND
25 COMPLIANCE OF THE FINANCE AND ADMINISTRATION
26 DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
30 within the City's budget, there are hereby appropriated the
31 indicated sum(s) from the account(s) listed in subsection (a) to

1 the account(s) listed in subsection (b):

3 incorporated herein by this reference)

8 (c) **Explanation of Appropriation** - The funding above is being
9 appropriated from the designated City Council Operating
10 Contingency to The Jacksonville Historical Society, Inc.

11 **Section 2. Purpose.** The purpose of the appropriation in
12 Section 1 is to provide \$35,000.00 in funding to The Jacksonville
13 Historical Society, Inc. to be used as match funding for
14 renovations to the Florida Casket Company Building, located at 314
15 Palmetto Street, Jacksonville, Florida 32202, in order to maintain
16 and preserve old Duval County Courthouse records and photo
17 negatives from the Florida Times-Union which are utilized by
18 archivists to review, organize and secure historical documents.

19 **Section 3. Carryover.** The funds appropriated in Section 1
20 of this ordinance shall not lapse but shall carryover into fiscal
21 year 2020-2021.

22 **Section 4. Authorizing the Mayor and Corporation**
23 **Secretary to Execute Contract with the Jacksonville Historical**
24 **Society, Inc.** The Mayor, or his designee, and Corporation Secretary
25 are authorized to execute a contract with The Jacksonville
26 Historical Society, Inc. for contribution of \$35,000 to match
27 funding received from other sources, including a matching grant
28 from Delores Barr Weaver, in substantially the same form as
29 contained in **Exhibit 2** attached hereto and, by this reference made
30 a part hereof.

31 **Section 5. Invoking the exception pursuant to Section**

1 **126.107(g), Ordinance Code.** The City is hereby authorized to enter
2 into a grant agreement with The Jacksonville Historical Society,
3 Inc. to provide funding to The Jacksonville Historical Society,
4 Inc. to be used for contribution of \$35,000 to match funding
5 received from other sources for renovations to the Florida Casket
6 Company Building. Pursuant to Section 126.107(g), Ordinance Code,
7 such procurement is exempted from competitive solicitation. With
8 the exception of the foregoing, all other provisions of Chapter
9 126, *Ordinance Code*, shall remain in full force and effect.

10 **Section 6. Waiver of Section 118.201(f) (7) (Release of**
11 **Appropriations), Ordinance Code.** Section 118.201(f) (7) (Release of
12 Appropriations), Chapter 118 (City Grants), *Ordinance Code*, is
13 hereby waived as to the disbursement of funds based upon draws for
14 services performed or reimbursements for work done. Waiver of
15 Section 118.201(f) (7), *Ordinance Code*, is requested in order to
16 allow upfront payment to The Jacksonville Historical Society, Inc.
17 with an allowance for a reasonable retainer.

18 **Section 7. Oversight Department.** The Office of Grants and
19 Compliance of the Finance and Administration Department shall
20 oversee the project described herein.

21 **Section 8. Effective Date.** This ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
