5 A RESOLUTION CONFIRMING THE MAYOR'S  
6 REAPPOINTMENT OF PATRICK R. VICTOR, A ST.  
7 JOHNS COUNTY RESIDENT WITH SUBSTANTIAL  
8 BUSINESS INTEREST IN DUVAL COUNTY, PURSUANT TO  
9 SECTION 50.102, *ORDINANCE CODE*, TO THE  
10 SUBDIVISION STANDARDS AND POLICY ADVISORY  
11 COMMITTEE, AS A REPRESENTATIVE OF THE  
12 ENGINEERING PROFESSION, PURSUANT TO SECTION  
13 654.142, *ORDINANCE CODE*, FOR A SECOND FULL  
14 TERM TO EXPIRE NOVEMBER 30, 2022; PROVIDING  
15 FOR A NON-RESIDENT OF DUVAL COUNTY WITH  
16 SUBSTANTIAL ECONOMIC BUSINESS INTEREST TO BE  
17 SEATED ON THE SUBDIVISION STANDARDS AND POLICY  
18 ADVISORY COMMITTEE; PROVIDING AN EFFECTIVE

21 **BE IT RESOLVED** by the Council of the City of Jacksonville:

22 **Section 1. Reappointment.** The Council hereby confirms the  
23 reappointment of Patrick R. Victor, a St. Johns County resident  
24 with substantial business interest in Duval County, pursuant to  
25 Section 50.102, *Ordinance Code*, to the Subdivision Standards and  
26 Policy Advisory Committee, as a representative of the engineering  
27 profession, pursuant to Section 654.142, *Ordinance Code*, for a  
28 second full term to expire November 30, 2022.

29 **Section 2. A Non-Resident of Duval County with**  
30 **substantial economic business interests in Duval County.** Section  
31 50.102 (Members of boards and commissions), *Ordinance Code*,  
32 requires Board and Commission members be either a Duval County

1 resident or individuals with substantial economic business or  
2 philanthropic interests in Duval County. Mr. Victor has substantial  
3 business interests in Duval County. Mr. Victor has served for 21  
4 years as a Vice President, Partner and Officer-in-charge for North  
5 Florida-Georgia for CDM Smith, located at 8381 Dix Ellis Trail,  
6 Suite 400, Jacksonville, Florida 32256.

7 **Section 3. Effective Date.** This resolution shall become  
8 effective upon signature by the Mayor or upon becoming effective  
9 without the Mayor's signature.
