8 AN ORDINANCE APPROPRIATING \$34,435.00 IN  
9 UNALLOCATED/TRUST FUND AUTHORIZED EXPENDITURES  
10 FROM THE RENEW ARLINGTON CRA TRUST FUND TO  
11 SALARIES PART-TIME (IN THE AMOUNT OF  
12 \$30,000.00) MEDICARE TAX (IN THE AMOUNT OF  
13 \$435.00) AND ADVERTISING AND MARKETING FOR THE  
14 COMPLIANCE GRANT PROGRAM (IN THE AMOUNT OF  
15 \$4,000.00), AS INITIATED BY B.T. 20-041;  
16 APPROVING PART-TIME HOURS, AS INITIATED BY  
17 R.C. 20-066; PROVIDING AN EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2019-2020 fiscal year,  
21 within the City's budget, there are hereby appropriated the  
22 indicated sum(s) from the account(s) listed in subsection (a) to  
23 the account(s) listed in subsection (b):

30 (c) Explanation of Appropriation

1           The appropriation above comprises \$30,435.00 of  
2           Unallocated/Trust Fund Authorized Expenditures from the  
3           Renew Arlington CRA Trust Fund to Salaries Part-Time and  
4           Medicare Tax, as well as \$4,000.00 from the same source  
5           for advertising and marketing of the Compliance Grant  
6           Program.

7           **Section 2. Purpose.** Ordinance 2019-239-E authorized the  
8           creation of the Renew Arlington (RA) Zoning Overlay, and Ordinance  
9           2019-879 is currently in the process of amending the Zoning Code to  
10          create a consolidated review process within the Planning &  
11          Development Department for properties within the RA Zoning Overlay  
12          that are out of conformance with overlay guidelines for fences,  
13          landscaping/landscape buffers, and signage. In order to assist with  
14          the design, development, review, and inspection of construction  
15          projects for the Renew Arlington Mandatory Compliance Grant Program  
16          offered to property owners/applicants located within the Renew  
17          Arlington Community Redevelopment Area (CRA), the Office of  
18          Economic Development (OED) will hire a part-time professional  
19          landscape designer to be funded by available Unallocated Plan  
20          Authorized Expenditures from the Renew Arlington CRA budget.  
21          Ordinance 2018-555-E revised the City's Community Redevelopment  
22          Agencies, including amendments to Chapter 106, *Ordinance Code*. In  
23          compliance with Section 106.341, *Ordinance Code*, a CRA board may  
24          not transfer funds within the Administrative Expenditures Category  
25          without Council approval. The purpose of this legislation is to  
26          approve the appropriation of funds for the position and additional  
27          funding for advertising and marketing of the Compliance Grant  
28          Program. The funding will allow for up to 400 part-time hours; the  
29          landscape designer will report to the Executive Director of the  
30          OED. A copy of the Renew Arlington CRA Board Resolution is attached  
31          hereto as **Exhibit 3**.

1           **Section 3.           Approval of Part-time hours.**           There are  
2 hereby approved the part-time hours more fully described in R.C.  
3 20-066, attached hereto as **Exhibit 2** and incorporated herein by  
4 this reference.

5           **Section 4.           Effective Date.**           This ordinance shall become  
6 effective upon signature by the Mayor or upon becoming effective  
7 without the Mayor's signature.
