AN ORDINANCE APPROPRIATING A \$7,656.00 PROJECT AWARD THROUGH THE NORTHEAST FLORIDA HEALTHCARE COALITION (NEFLHCC), WITH NO LOCAL MATCH, TO PROVIDE FUNDING FOR THE INITIAL PURCHASE OF STOP THE BLEED KITS, AS INITIATED BY B.T. 20-036; APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY, THE MEMORANDUM OF AGREEMENT BETWEEN THE NORTHEAST FLORIDA REGIONAL COUNCIL AND CITY OF JACKSONVILLE; PROVIDING FOR OVERSIGHT BY THE JACKSONVILLE FIRE AND RESCUE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

(c) Explanation of Appropriation

The appropriation above is a Project award through the

Northeast Florida Healthcare Coalition (NEFLHCC) for the purchase of 200 bleeding control kits. The NEFLHCC award is a "reimbursement" award, which requires initial purchase of the bleeding control kits by the Jacksonville Fire and Rescue Department (JFRD), followed by 100% reimbursement of the costs up to the award amount of \$7,656.00 by NEFLHCC. There is no City match.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for the initial purchase of Stop the Bleed Kits. Uncontrolled bleeding is the number one cause of preventable traumatic death. The bleeding control kits contain essential life-saving equipment necessary in the event of a large scale Mass Casualty Incident.

Section 3. Approval and authorization. There is hereby approved, and the Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City, the Memorandum of Agreement between the Northeast Florida Regional Council and City of Jacksonville, a copy of which is attached hereto as Exhibit 2 and incorporated herein by this reference (the "MOA"). Pursuant to the MOA, the bleeding control kits must be purchased and received by JFRD no later than May 1, 2020, in order to receive reimbursement from the Northeast Florida Regional Council.

Section 4. Oversight. JFRD shall oversee the project described herein.

Section 5. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
