5 AN ORDINANCE APPROPRIATING \$600,000.00 FROM
6 INTEREST EARNINGS THE TAX COLLECTOR RECEIVES
7 ON DEPOSITED FUNDS WHICH BENEFIT ALL OF ITS
8 RECIPIENTS, INCLUDING THE STATE OF FLORIDA,
9 THE CITY OF JACKSONVILLE, THE DUVAL COUNTY
10 SCHOOL BOARD, AND VARIOUS OTHER TAXING
11 AUTHORITIES AND COMMUNITY DEVELOPMENT AND
12 SPECIAL DISTRICTS TO PROVIDE FUNDS TO PROCURE
13 A NEW TAX COLLECTION SYSTEM FOR THE DUVAL
14 COUNTY TAX COLLECTOR'S OFFICE, AS INITIATED BY
15 B.T. 20-052; PROVIDING FOR A CARRYOVER OF
16 FUNDS INTO FISCAL YEAR 2020-2021; PROVIDING
17 FOR AN EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
21 within the City's budget, there are hereby appropriated the
22 indicated sum(s) from the account(s) listed in subsection (a) to
23 the accounts listed in subsection (b):

24 (B.T. 20-052, attached hereto as **Exhibit 1** and incorporated herein
25 by this reference):

30 (c) Explanation of appropriation:
31 The funding above is from interest earnings the Tax

1 Collector receives on deposited funds which benefit all
2 of its recipients, including the State of Florida, the
3 City of Jacksonville, the Duval County School Board and
4 various other taxing authorities and community
5 development and special districts. No matching funds are
6 required. There is ongoing maintenance required, which
7 will be included in the regular budget submission
8 annually.

9 **Section 2. Carryover.** The funds appropriated in Section 1
10 of this ordinance shall not lapse but shall carryover into fiscal
11 year 2020-2021.

12 **Section 3. Purpose.** The purpose of the appropriation in
13 Section 1 is to provide funds to procure a new tax collection
14 system for the Duval County Tax Collector's Office.

15 **Section 4. Effective Date.** This ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
