6 **ORDINANCE 2020-115-E**

7 AN ORDINANCE APPROPRIATING \$35,000.00 FROM A
8 CITY COUNCIL OPERATING CONTINGENCY TO THE
9 JACKSONVILLE HISTORICAL SOCIETY, INC. TO BE
10 USED FOR RENOVATIONS TO THE FLORIDA CASKET
11 COMPANY BUILDING, LOCATED AT 314 PALMETTO
12 STREET, JACKSONVILLE, FLORIDA 32202; PROVIDING
13 FOR A CARRYOVER OF FUNDS INTO THE 2020-2021
14 FISCAL YEAR; APPROVING AND AUTHORIZING
15 EXECUTION OF AGREEMENT BY THE MAYOR OR HIS
16 DESIGNEE AND CORPORATION SECRETARY; INVOKING
17 THE EXCEPTION TO SECTION 126.107(G), *ORDINANCE*
18 *CODE*, IN ORDER TO DIRECT CONTRACT WITH THE
19 JACKSONVILLE HISTORICAL SOCIETY, INC.;
20 PROVIDING FOR WAIVER OF SECTION 118.201(F) (7)
21 (RELEASE OF APPROPRIATIONS), *ORDINANCE CODE*, IN
22 ORDER TO ALLOW UPFRONT PAYMENTS TO JACKSONVILLE
23 HISTORICAL SOCIETY, INC. WITH AN ALLOWANCE FOR
24 A REASONABLE RETAINER; PROVIDING FOR CITY
25 OVERSIGHT BY THE OFFICE OF GRANTS AND
26 COMPLIANCE OF THE FINANCE AND ADMINISTRATION
27 DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

29 **BE IT ORDAINED** by the Council of the City of Jacksonville:

30 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
31 within the City's budget, there are hereby appropriated the

1 indicated sum(s) from the account(s) listed in subsection (a) to
2 the account(s) listed in subsection (b):

4 incorporated herein by this reference)

9 (c) **Explanation of Appropriation** - The funding above is being
10 appropriated from the designated City Council Operating
11 Contingency to The Jacksonville Historical Society, Inc.

12 **Section 2. Purpose.** The purpose of the appropriation in
13 Section 1 is to provide \$35,000.00 in funding to The Jacksonville
14 Historical Society, Inc. to be used as match funding for
15 renovations to the Florida Casket Company Building, located at 314
16 Palmetto Street, Jacksonville, Florida 32202, in order to maintain
17 and preserve old Duval County Courthouse records and photo
18 negatives from the Florida Times-Union which are utilized by
19 archivists to review, organize and secure historical documents.

20 **Section 3. Carryover.** The funds appropriated in Section 1
21 of this ordinance shall not lapse but shall carryover into fiscal
22 year 2020-2021.

23 **Section 4. Authorizing the Mayor and Corporation**
24 **Secretary to Execute Contract with the Jacksonville Historical**
25 **Society, Inc.** The Mayor, or his designee, and Corporation Secretary
26 are authorized to execute a contract with The Jacksonville
27 Historical Society, Inc. for contribution of \$35,000 to match
28 funding received from other sources, including a matching grant
29 from Delores Barr Weaver, in substantially the same form as
30 contained in **Revised Exhibit 2**, labeled as "Revised Exhibit 2, Rev
31 Contract, March 2, 2020 - NCSPHS" attached hereto and, by this

1 reference made a part hereof.

2 **Section 5. Invoking the exception pursuant to Section**
3 **126.107(g), Ordinance Code.** The City is hereby authorized to enter
4 into a grant agreement with The Jacksonville Historical Society,
5 Inc. to provide funding to The Jacksonville Historical Society,
6 Inc. to be used for contribution of \$35,000 to match funding
7 received from other sources for renovations to the Florida Casket
8 Company Building. Pursuant to Section 126.107(g), Ordinance Code,
9 such procurement is exempted from competitive solicitation. With
10 the exception of the foregoing, all other provisions of Chapter
11 126, *Ordinance Code*, shall remain in full force and effect.

12 **Section 6. Waiver of Section 118.201(f) (7) (Release of**
13 **Appropriations), Ordinance Code.** Section 118.201(f) (7) (Release of
14 Appropriations), Chapter 118 (City Grants), *Ordinance Code*, is
15 hereby waived as to the disbursement of funds based upon draws for
16 services performed or reimbursements for work done. Waiver of
17 Section 118.201(f) (7), *Ordinance Code*, is requested in order to
18 allow upfront payment to The Jacksonville Historical Society, Inc.
19 with an allowance for a reasonable retainer.

20 **Section 7. Oversight Department.** The Office of Grants and
21 Compliance of the Finance and Administration Department shall
22 oversee the project described herein.

23 **Section 8. Effective Date.** This ordinance shall become
24 effective upon signature by the Mayor or upon becoming effective
25 without the Mayor's signature.
