15 PROVIDERS OF SERVICES OR EMPLOYEES OF THE

20 **Section 1. Appointment.** The Council hereby appoints
21 Susan McCullough, a Duval County resident, to the Jacksonville -
22 Duval County Council on Elder Affairs, as the representative for
23 Council District 14, filling a seat formerly held by Henry W. Cook
24 in accordance with Chapter 82, *Ordinance Code*, for a first full
25 term ending June 30, 2021.

26 **Section 2. Waiving Section 82.102(a)(2) (Composition of**
27 **membership; officers), *Ordinance Code*.** Section 82.102(a)(2)
28 (Composition of membership; officers), *Ordinance Code*, requiring
29 members of the Jacksonville - Duval County Council on Elder Affairs
30 should not be providers of services or employees of the local,
31 state or federal government, is hereby waived to allow Susan

1 McCullough, a Duval County resident, who is employed by the
2 Supervisor of Elections as an Inspector Technician, to serve on the
3 Jacksonville - Duval County Council on Elder Affairs.

4 **Section 3. Effective Date.** This ordinance shall become
5 effective upon signature by the Mayor or upon becoming effective
6 without the Mayor's signature.
