5 AN ORDINANCE APPROPRIATING \$56,058.00 IN GRANT  
6 FUNDING, WITH NO LOCAL MATCH, FROM THE FLORIDA  
7 DEPARTMENT OF LAW ENFORCEMENT UNDER THE PRISON  
8 RAPE ELIMINATION ACT (PREA) TO PURCHASE  
9 OPERATING SUPPLIES FOR THE PREA INMATE  
10 EDUCATION INITIATIVE AND TO INCREASE VIDEO  
11 SURVEILLANCE AT JSO CORRECTIONAL FACILITIES,  
12 AS INITIATED BY B.T. 20-048; PROVIDING AN  
13 EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2019-2020 fiscal year,  
17 within the City's budget, there are hereby appropriated the

26 (c) **Explanation of Appropriation**

27 The appropriation above is grant funding, with no local  
28 match, from the Florida Department of Law Enforcement  
29 under the Prison Rape Elimination Act (PREA) to purchase  
30 operating supplies for the PREA Inmate Education  
31 Initiative and to increase video surveillance at JSO

1                   correctional facilities.

2           **Section 2.           Purpose.**   The purpose of the appropriation in  
3 Section 1 is to provide funding to enhance the Jacksonville  
4 Sheriff's Office's compliance with the Prison Rape Elimination Act  
5 (PREA) by purchasing additional signage, adding additional  
6 surveillance equipment to correctional facilities, and sending  
7 staff to training classes. The grant period is from February 1,  
8 2020, through September 30, 2020. A copy of the Application for  
9 Funding Assistance to the Florida Department of Law Enforcement for  
10 funding under the Prison Rape Elimination Act has been placed **ON**  
11 **FILE** with the Office of Legislative Services. A copy of the  
12 Acceptance of Federal Funding Assistance is attached hereto as  
13 **Exhibit 2.**

14           **Section 3.           Effective Date.**   This ordinance shall become  
15 effective upon signature by the Mayor or upon becoming effective  
16 without the Mayor's signature.
