RESOLUTION 2020-189-A

A RESOLUTION HONORING THE LIFE AND COUNTLESS CONTRIBUTIONS OF ROBERT "BOB" SHIRCLIFF; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Robert "Bob" Shircliff was born in Vincennes, Indiana on May 20, 1928 to Thomas Maxwell and Martha Shircliff, and started working part-time in his father's Pepsi-Cola bottling plant when he was just eight years old; and

WHEREAS, Mr. Shircliff was a member of the Reserve Officers' Training Corps in high school and in college, and graduated with a Bachelor of Science degree in Marketing from Indiana University in 1950, and also served in the Army Reserves until 1963 when he retired as a Captain in Military Intelligence; and

WHEREAS, Robert Shircliff married the love of his life Carol Reed in 1953, and they were devoted to one another for 66 years. The Shircliffs were blessed with two daughters, Elizabeth and Laura, and later with four grandchildren and seven great-grandchildren; and

WHEREAS, after college, Bob Shircliff joined his father's Pepsi-Cola bottling business full-time. During his 18 year tenure he was elected President of Pepsi-Cola Allied Bottlers, Inc. and was President of the National Pepsi-Cola Bottlers Association; and

WHEREAS, Bob Shircliff's career with Pepsi took his family from Bloomington to Charleston, West Virginia, and then to Jacksonville where they settled in 1967, and after the sale of the family

business to the General Cinema Corporation, Mr. Shircliff served on its board and oversaw twelve of its subsidiaries before departing to start his own consulting firm which eventually became known as The Shircliff Group; and

WHEREAS, Mr. Shircliff was a civic leader for numerous organizations. He was a charter member and former President of the Rotary Club of West Jacksonville, President of the River Club, Chairman of the Jacksonville Regional Chamber of Commerce, Chairman of the Jacksonville Community Foundation, Chairman of the American Red Cross of Duval County, President of the United Way of Jacksonville, and also chaired the boards of the Jacksonville Symphony Association and the Cummer Museum of Art & Gardens. Mr. Shircliff served on the boards of several business entities, including Alliance Mortgage Corporation, Atlantic National Bank of Jacksonville, and Everbank Financial Corporation; and

WHEREAS, Bob Shircliff was a philanthropist and fundraiser extraordinaire who helped to raise nearly \$300 million to benefit the Jacksonville community over a period of approximately 45 years. Mr. Shircliff was a board member at Jacksonville University for 23 years, and led two successful capital campaigns on the campus. He was a member of St. Matthew's Catholic parish for 53 years and led capital campaigns to build two new Catholic high schools within the Diocese of St. Augustine. Bob Shircliff may have been best known for his championship and support of St. Vincent's Healthcare, wherein he chaired or co-chaired four capital campaigns, Chairman of St. Vincent's Health System and the St. Vincent's Medical Center Advisory Board, was the founding Chairman of the St. Vincent's Foundation, vice-chair of Baptist St. Vincent's Health System, and was a director of the Daughters of Charity National Health System. In 2007, the City of Jacksonville recognized his extraordinary contributions by renaming a portion of Barrs Street

in front of St. Vincent's Hospital to "Shircliff Way"; and

WHEREAS, Robert Shircliff was honored with numerous awards for his civic and charitable endeavors, including the 2018 Thompson S. Baker Award from Junior Achievement of North Florida and the Association of Fundraising Professionals' First Coast chapter's Lifetime Achievement Award. In 2001, Mr. Shircliff was presented with the Pro Ecclesia et Pontifice Cross by Pope John Paul II for distinguished service to the Catholic Church. He was honored by the Jacksonville Regional Chamber of Commerce, Jacksonville University, Leadership Jacksonville, Prevent Blindness, Inc., Volunteer Jacksonville, OneJax (with both its Gold Humanitarian Award and a Silver Medal). The National Society of Fundraising Executives awarded Bob Shircliff with both the Philanthropist of the Year and National Volunteer Fund Raiser of the Year, and he was also was named to the Business Hall of Fame by the Florida Economic Education Foundation; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City of Jacksonville hereby honors the life of Robert Shircliff and his countless contributions to our city. Bob was known for his integrity, humility and of course trademark bowtie. He will be always be remembered as an exceptional husband, father, grandfather, neighbor and gracious leader whose humor and kindness endeared him to everyone he met. Robert Shircliff loved to give to others, inspired others to do the same and made Jacksonville a better place.

Section 2. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
