5 AN ORDINANCE AMENDING PART 16 (TRUCK ROUTE  
6 REGULATIONS), CHAPTER 804 (JACKSONVILLE  
7 TRAFFIC CODE), ORDINANCE CODE, TO ADD A NEW  
8 SECTION 804.1607 (CERTAIN DUMP TRUCKS  
9 PROHIBITED) TO PROHIBIT OPERATORS OF DUMP  
10 TRUCKS WITH 10 OR MORE WHEELS FROM DRIVING ON,  
11 TRAVELING OVER OR USING THAT PORTION OF  
12 ROADWAYS FROM THE NORTHERNMOST POINT OF SAWPIT  
13 ROAD TO CEDAR POINT ROAD, WEST ON CEDAR POINT  
14 ROAD TO NEW BERLIN ROAD, AND SOUTH ON NEW  
15 BERLIN ROAD UNTIL ITS TERMINATION AT HECKSCHER  
16 DRIVE IN JACKSONVILLE; DIRECTING THE  
17 JACKSONVILLE SHERIFF'S OFFICE TO ISSUE  
18 WARNINGS FOR THE FIRST 6 MONTHS AFTER THE  
19 EFFECTIVE DATE OF THIS ORDINANCE; PROVIDING  
20 FOR AN EFFECTIVE DATE.

22 **Section 1. Amending Part 16 (Truck Route Regulations) to**  
23 **add a new Section 804.1607 (Certain Dump Trucks Prohibited),**  
24 **Chapter 804 (Jacksonville Traffic Code), Ordinance Code.** Part 16  
25 (Truck Route Regulations), Chapter 804 (Jacksonville Traffic Code),  
26 *Ordinance Code*, is hereby amended to read as follows:

27 **CHAPTER 804. JACKSONVILLE TRAFFIC CODE.**

29 **PART 16. TRUCK ROUTE REGULATIONS**

31 **Sec. 804.1607 - Certain Dump Trucks Prohibited.**

1 (a) Operators of Dump Trucks having 10 or more wheels are  
2 hereby prohibited from traveling over, driving on or  
3 using that portion of roadways from the northernmost  
4 point of Sawpit Road, south to Cedar Point Road, west on  
5 Cedar Point Road to New Berlin Road, and south on New  
6 Berlin Road until its termination at Heckscher Drive in  
7 Jacksonville.

8 (b) The Jacksonville Sheriff's Office shall enforce this  
9 Section in accordance with the provisions of Section  
10 804.1606, Ordinance Code, provided a warning shall be  
11 issued for 6 months after enactment of this Section.

12  
13 **Section 2. Directing the Jacksonville Sheriff's Office to**  
14 **issue warnings for the first 6 months after the effective date of**  
15 **this Ordinance.** The Jacksonville Sheriff's Office shall issue  
16 warnings for a time period that shall expire 6 months from the  
17 effective date of this ordinance.

18 **Section 3. Effective Date.** This ordinance shall become  
19 effective upon signature by the Mayor or upon becoming effective  
20 without the Mayor's signature.
