A RESOLUTION HONORING AND COMMENDING COUNCIL
AUDITOR KYLE BILLY ON THE OCCASION OF HIS
RETIREMENT AFTER 31 YEARS OF OUTSTANDING
SERVICE TO THE CITY OF JACKSONVILLE; PROVIDING
AN EFFECTIVE DATE.

WHEREAS, Jacksonville native Kyle Billy earned his bachelor's degree in accounting from Jacksonville University, earned his master's degree in accounting from the University of North Florida, and has been a Certified Public Accountant since 1990; and

WHEREAS, Mr. Billy was hired as an entry-level auditor in the Council Auditor's Office in January 1989 by then-Council Auditor Bob Johnson, the second Council Auditor appointed under the consolidated form of government created in 1968. Mr. Johnson, for whom the Robert O. Johnson Award was created to memorialize his many decades of outstanding public service, was the consolidated city's first Assistant Council Auditor in 1968, so Mr. Billy's auditing roots go back through him to the foundation of the consolidated government more than five decades ago; and

WHEREAS, Kyle Billy progressed steadily through the ranks of the Auditor's Office from Auditor 1 through Principal Auditor, managing audits and reviewing key legislation, particularly regarding independent authorities, selecting and training many staff members, coordinating a wide range of special projects and producing quarterly summary reports. When promoted to Assistant

Council Auditor in 2014, he managed the office's City Council support functions and became the face of the office, leading to a smooth transition as Council Auditor three years later in 2017 when, following the retirement of Council Auditor Kirk Sherman, Mr. Billy was appointed his successor and became the fifth Council Auditor of the consolidated government; and

WHEREAS, Mr. Billy, whose wife Janice also had a long and stellar career of her own in the Council Auditor's Office prior to her retirement several years ago, is renowned for his incredible work ethic, his attention to minute details, and his dogged determination to see every task through to absolute perfect completion. He is known among his co-workers as a demanding but fair leader who treats everyone with the same degree of courtesy and respect and expects that example to be the standard by which his team interacts with clients, auditees, and others. encyclopedic knowledge of the city government gained through more than three decades of audits of every branch of the government and its independent authorities, of budget reviews in good years and bad, of legislative support of the City Council and its committees, and of special investigatory reports of hot topics over the years are invaluable in his current role as the most trusted advisor to the City Council collectively and to each of its members; and

WHEREAS, Kyle Billy has been deeply involved in researching and reporting on some of the most important and high-profile issues facing the city government over the past three decades, including, among others, the county courthouse construction project, the dredging of the St. Johns River, and most recently the potential privatization of JEA. The work of Mr. Billy and his staff were absolutely crucial in giving the City Council and the citizens of Jacksonville a true understanding of the potential ramifications of the sale of JEA and especially of the utility's Performance

Incentive Plan that could have yielded huge payouts to some employees had the JEA been privatized; and

WHEREAS, Mr. Billy's retirement will allow him more time to indulge his many non-work interests, including spending more time with his children and grandchildren, exercising fanatically, and traveling, especially to more of his beloved national parks; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City of Jacksonville hereby honors and commends Council Auditor Kyle Billy on the occasion of his retirement after three decades of outstanding service in the Council Auditor's Office. The City Council expresses its utmost gratitude to Mr. Billy for his knowledge, his dedication, his friendship, and his unfailing wise counsel to the Council and its members over the years, and we wish him the very best of health and happiness in his retirement.

Section 2. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
