AN ORDINANCE REZONING APPROXIMATELY 4.91± ACRES LOCATED IN COUNCIL DISTRICT 6 AT 12217 OLD ST. AUGUSTINE ROAD, BETWEEN ARIANA ELYSE DRIVE AND FRENCH LANE (R.E. NO. 157212-0000), DESCRIBED HEREIN, OWNED BY THE ALAN MICHAEL WINTERS TRUST, FROM RESIDENTIAL RURAL-ACRE (RR-ACRE) DISTRICT TO RESIDENTIAL LOW DENSITY-70 (RLD-70) DISTRICT, AS DEFINED AND CLASSIFIED UNDER THE ZONING CODE; PROVIDING A DISCLAIMER THAT THE REZONING GRANTED HEREIN SHALL NOT BE CONSTRUED AS AN EXEMPTION FROM ANY APPLICABLE LAWS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Alan Michael Winters Trust, the owner of approximately 4.91± acres located in Council District 6 at 12217 Old St. Augustine Road, between Ariana Elyse Drive and French Lane (R.E. No. 157212-0000), as more particularly described in Exhibit 1, dated February 6, 2020, and graphically depicted in Exhibit 2, both of which are attached hereto (Subject Property), has applied for a rezoning and reclassification of the Subject Property from Residential Rural-Acre (RR-Acre) District to Residential Low Density-70 (RLD-70) District; and

WHEREAS, taking into consideration the above recommendations and all other evidence entered into the record and testimony taken at the public hearings, the Council finds that such rezoning: (1) consistent with the 2030 Comprehensive Plan; (2) furthers the goals, objectives and policies of the 2030 Comprehensive Plan; and (3) is not in conflict with any portion of the City's land use regulations; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville: Section 1. Property Rezoned. The Subject Property is hereby rezoned and reclassified from Residential Rural-Acre (RR-Acre) District to Residential Low Density-70 (RLD-70) District, as defined and classified under the Zoning Code, City of Jacksonville, Florida.

Issuance of this rezoning does not approve, promote or condone any practice or act that is prohibited or restricted by any federal, state or local laws.
