5 AN ORDINANCE APPROPRIATING \$2,220,000  
6 (\$1,620,000 FROM THE DUVAL COUNTY TOURIST  
7 DEVELOPMENT COUNCIL ("TDC") SPECIAL REVENUE  
8 FUND DEVELOPMENT ACCOUNT AND \$600,000 FROM THE  
9 TDC SPECIAL REVENUE FUND CONTINGENCY ACCOUNT)  
10 TO THE TDC OPERATIONS ACCOUNT TO PROVIDE  
11 FUNDING FOR TDC OPERATIONS TO OFFSET THE  
12 ANTICIPATED LOSSES IN TOURIST DEVELOPMENT  
13 TAXES DUE TO COVID-19 IN FISCAL YEAR 2019-  
14 2020; PURPOSE; AMENDING THE TDC FISCAL YEAR  
15 2019-2020 BUDGET (SECOND REVISED SCHEDULE W)  
16 APPROVED BY ORDINANCE 2019-504-E (CITY'S  
17 ANNUAL BUDGET) AND ORDINANCE 2020-251-E, TO  
18 PROVIDE FUNDING FOR TDC OPERATIONS TO OFFSET  
19 THE ANTICIPATED LOSSES IN TOURIST DEVELOPMENT  
20 TAXES DUE TO COVID-19 IN FISCAL YEAR 2019-  
21 2020; PROVIDING FOR WAIVER OF SECTION  
22 111.600 (B) (DEVELOPMENT ACCOUNT; EXPENDITURES),  
23 PART 6 (ECONOMIC AND COMMUNITY DEVELOPMENT),  
24 CHAPTER 111 (SPECIAL REVENUE AND TRUST  
25 ACCOUNTS), *ORDINANCE CODE*, SO AS TO ALLOW THE  
26 DEVELOPMENT ACCOUNT FUNDS APPROPRIATED HEREIN  
27 TO BE USED TO OFFSET THE ANTICIPATED LOSSES IN  
28 TOURIST DEVELOPMENT TAXES DUE TO COVID-19;  
29 PROVIDING FOR WAIVER OF SECTION 666.108 (D)  
30 (1) (DEVELOPMENT ACCOUNT), CHAPTER 666 (DUVAL  
31 COUNTY TOURIST DEVELOPMENT PLAN), *ORDINANCE*

1 CODE, SO AS TO ALLOW THE DEVELOPMENT ACCOUNT  
2 FUNDS APPROPRIATED HEREIN TO BE USED TO OFFSET  
3 THE ANTICIPATED LOSSES IN TOURIST DEVELOPMENT  
4 TAXES DUE TO COVID-19; PROVIDING FOR WAIVER OF  
5 SECTION 666.108(D)(2) (CONTINGENCY ACCOUNT),  
6 CHAPTER 666 (DUVAL COUNTY TOURIST DEVELOPMENT  
7 PLAN), ORDINANCE CODE, SO AS TO ALLOW THE  
8 CONTINGENCY ACCOUNT FUNDS APPROPRIATED HEREIN  
9 TO BE USED TO OFFSET THE ANTICIPATED LOSSES IN  
10 TOURIST DEVELOPMENT TAXES DUE TO COVID-19;  
11 PROVIDING FOR OVERSIGHT BY THE TDC; REQUESTING  
12 ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN  
13 EFFECTIVE DATE.

15 **WHEREAS**, the Duval County Tourist Development Council (the  
16 "Tourist Development Council" or "TDC"), pursuant to Chapter 70,  
17 *Ordinance Code*, administers the Tourist Development Plan set forth  
18 in Chapter 666, *Ordinance Code*; and

19 **WHEREAS**, the TDC at its regular meeting on May 28, 2020,  
20 unanimously voted to recommend to the City Council for approval a  
21 total transfer of \$1,620,000 from the TDC Special Revenue Fund  
22 Development Account and \$600,000 from the TDC Contingency Account  
23 to the TDC Operations Account to offset anticipated losses in  
24 tourist development tax revenues in fiscal year 2019-2020; now  
25 therefore

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Recitals.** The recitals set forth above are  
28 true and correct and incorporated herein by reference.

29 **Section 2. Appropriation.** For the 2019-2020 fiscal year,  
30 within the City's budget, there are hereby appropriated the  
31 indicated sum(s) from the account(s) listed in subsection (a) to

1 the account(s) listed in subsection (b):

8 (c) **Explanation of Appropriation.** This ordinance appropriates  
9 \$2,220,000 (\$1,620,000 from the TDC Special Revenue Fund  
10 Development Account and \$600,000 from the TDC Special  
11 Revenue Fund Contingency Account) to the Tourist  
12 Development Council Operations Account and  
13 correspondingly reduces the tourist development tax  
14 revenue by the same.

15 **Section 3. Purpose.** The purpose of the appropriation  
16 above is to transfer funding originally appropriated to the TDC  
17 Special Revenue Fund Development Account and TDC Special Revenue  
18 Fund Contingency Account to Tourist Development Council operations  
19 to help offset the anticipated losses in tourist development taxes  
20 due to COVID-19 in fiscal year 2019-2020.

21 **Section 4. Amending the TDC Fiscal Year 2019-2020 Budget**  
22 **(Second Revised Schedule W) approved by Ordinance 2019-504-E**  
23 **(City's Annual Budget) and subsequently revised by Ordinance 2020-**  
24 **251-E.** There is hereby amended the Fiscal Year 2019-2020 budget for  
25 the Tourist Development Council by replacing Second Revised  
26 Schedule W, approved by Ordinance 2019-504-E (City's annual budget)  
27 and subsequently revised by Ordinance 2020-251-E, with the Third  
28 Revised Schedule W attached hereto as **Exhibit 2** and incorporated  
29 herein by this reference, to provide funding to help offset the  
30 anticipated losses in tourist development taxes due to COVID-19 in  
31 fiscal year 2019-2020.

1           **Section 5.           Waiver of the provisions in Section 111.600(b)**  
2 **(Development account; expenditures), Part 6 (Economic and Community**  
3 **Development), Chapter 111 (Special Revenue and Trust Accounts),**  
4 **Ordinance Code.** The City hereby waives the provisions in Section  
5 111.600(b) (Development account; expenditures), Part 6 (Economic  
6 and Community Development), Chapter 111 (Special Revenue and Trust  
7 Accounts), with respect to the designated use of funds required  
8 therein. The waiver is needed to allow the use of the development  
9 account funds appropriated in this ordinance to offset anticipated  
10 losses in tourist development tax revenue in the 2019-2020 fiscal  
11 year.

12           **Section 6.           Waiver of the provisions in Section**  
13 **666.108(d) (1) (Development Account), Chapter 666 (Duval County**  
14 **Tourist Development Plan), Ordinance Code.** The City hereby waives  
15 the provisions in Section 666.108(d) (1) (Development Account),  
16 Chapter 666 (Duval County Tourist Development Plan), *Ordinance*  
17 *Code*, with respect to the designated use of funds required therein.  
18 The waiver is needed to allow the use of the development account  
19 funds appropriated in this ordinance to offset anticipated losses  
20 in tourist development tax revenue in the 2019-2020 fiscal year.

21           **Section 7.           Waiver of the provisions in Section**  
22 **666.108(d) (2) (Contingency Account), Chapter 666 (Duval County**  
23 **Tourist Development Plan), Ordinance Code.** The City hereby waives  
24 the provisions in Section 666.108(d) (2) (Contingency Account),  
25 Chapter 666 (Duval County Tourist Development Plan), *Ordinance*  
26 *Code*, with respect to the designated use of funds required therein.  
27 The waiver is needed to allow the use of the contingency account  
28 funds appropriated in this ordinance to offset anticipated losses  
29 in tourist development tax revenue in the 2019-2020 fiscal year.

30           **Section 8.           Oversight.** The TDC shall oversee the funds  
31 appropriated herein.
