RESOLUTION 2020-323

A RESOLUTION DESIGNATING THE MONTH OF JUNE AS POST-TRAUMATIC STRESS DISORDER AWARENESS MONTH IN JACKSONVILLE; REQUESTING EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Post-Traumatic Stress Disorder (PTSD) is a mental health problem that some people develop after experiencing or witnessing a life-threatening event, like combat, a natural disaster, a car accident, or sexual assault; and

WHEREAS, anyone can develop PTSD at any age and PTSD presents with a range of symptoms, the cause of which may be overlooked or misdiagnosed as having resulted from past trauma; and

WHEREAS, there are currently about 8 million people in the United States with PTSD; and

WHEREAS, seven to eight out of every 100 Americans will experience PTSD at some point during their lives, with women being twice as likely as men to develop PTSD, and those who suffer from PTSD are more likely to attempt suicide and 2-4 times more likely to have a substance use disorder; and

WHEREAS, over 540,000 veterans have been diagnosed with PTSD and nearly 300,000 veterans who returned from Iraq and Afghanistan are currently suffering from PTSD; and

WHEREAS, depression and PTSD are the most common mental health

 problems faced by returning troops, with 30% of soldiers developing mental health problems within 3-4 months of being home, and unfortunately, 20-22 veterans commit suicide each day in the United States; and

WHEREAS, the annual cost to society of anxiety disorders is estimated to be over \$42.3 billion often due to misdiagnosis and ongoing treatment and people with PTSD have among the highest rates of healthcare service use, with almost 50% of all outpatient mental health patients having PTSD; and

WHEREAS, according to the U.S. Department of Veterans Affairs, in the past year the number of diagnosed cases in the military has jumped 50%, and this figure represents only those reported and diagnosed, and it is important to understand and encourage those individuals with PTSD to assist them in handling their stress and PTSD and help them to move forward; and

WHEREAS, in general, promoting mental health and wellness leads to higher overall productivity, better educational outcomes, lower crime rates, stronger economies, lower health care costs, improved family life, improved quality of life and increased lifespan; and

WHEREAS, the goal of PTSD Awareness Month is to spread awareness about PTSD symptoms and effects, as well as advance the discussion about diagnosis, treatment, and care for those suffering from the effects of PTSD; and

WHEREAS, the Jacksonville City Council recognizes the importance of helping those who ae suffering from PTSD to find resources they need to start the healing process and recognizes the importance of awareness and education, access to services and acceptance of PTSD diagnosis and treatment to a person's overall success and supports the recognition of June as Post-Traumatic Stress Disorder Awareness month; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City of Jacksonville hereby declares the month of June as Post-Traumatic Stress Disorder Awareness month in Jacksonville and urges all citizens to help spread the word that effective PTSD treatments are available and that these treatments work and can lead to a better quality of life for those impacted. Citizens are urged to learn more about PTSD and to help raise awareness of the many different treatment options and make a difference in the lives of Veterans and others who have experienced trauma. To that end, the City supports awareness and education for the public, along with advocating for policies that support people with PTSD and their families.

pursuant to Council Rule 4.901 Emergency. Emergency passage upon introduction of this legislation is requested. The nature of the emergency is that June is designated nationally as Post-Traumatic Stress Disorder Awareness month and the City Council desires to show its support for the national dialogue on PTSD awareness and wishes to make strides locally for acceptance and support for individuals with PTSD within the local community.

Section 3. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
