5 AN ORDINANCE AUTHORIZING THE KIDS HOPE  
6 ALLIANCE TO PROVIDE DIRECT FUNDING IN THE  
7 AMOUNT OF \$631,018 TO THE JACKSONVILLE  
8 ALLIANCE FOR KIPP SCHOOLS, INC. TO ALLOW  
9 ENHANCED SERVICES TO BE PROVIDED TO AT-HOPE  
10 CHILDREN AND YOUTH IN JACKSONVILLE;  
11 APPROPRIATING \$444,698.00 FROM UNSPENT PART-  
12 TIME DOLLARS WITHIN THE KIDS HOPE ALLIANCE  
13 PRETEENS AND TEEN ESSENTIAL SERVICES CATEGORY  
14 INTO THE KIDS HOPE ALLIANCE OUT-OF-SCHOOL TIME  
15 ESSENTIAL SERVICES CATEGORY, AS INITIATED BY  
16 B.T. 20-090; INVOKING THE EXCEPTION OF SECTION  
17 126.107(G) (EXEMPTIONS), PART 1 (GENERAL  
18 REGULATIONS), CHAPTER 126 (PROCUREMENT CODE),  
19 *ORDINANCE CODE*, REGARDING CHILDREN'S SERVICES  
20 TO BE PROVIDED BY THE JACKSONVILLE ALLIANCE  
21 FOR KIPP SCHOOLS, INC. SPECIFIED IN THIS  
22 ORDINANCE; AUTHORIZING THE MAYOR, OR HIS  
23 DESIGNEE, AND CORPORATION SECRETARY, AND/OR  
24 THE CHIEF EXECUTIVE OFFICER OF THE KIDS HOPE  
25 ALLIANCE TO EXECUTE AND DELIVER A CHILDREN'S  
26 SERVICES CONTRACT WITH THE JACKSONVILLE  
27 ALLIANCE FOR KIPP SCHOOLS, INC.; WAIVING THE  
28 REQUIREMENTS OF SECTION 77.111(a) (PROVIDER  
29 CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE),  
30 *ORDINANCE CODE*, TO EXEMPT THE CHILDREN'S  
31 SERVICES PROGRAMMING TO BE PROVIDED BY THE

1 JACKSONVILLE ALLIANCE FOR KIPP SCHOOLS, INC.  
2 FROM COMPETITIVE PROCUREMENT; PROVIDING AN  
3 EFFECTIVE DATE.

5 **BE IT ORDAINED** by the Council of the City of Jacksonville:

6 **Section 1. Appropriation.** For the 2019-2020 fiscal year,  
7 within the City's budget, there are hereby appropriated the  
8 indicated sum(s) from the account(s) listed in subsection (a) to  
9 the account(s) listed in subsection (b):

16 (c) Explanation of appropriation

17 The funding above is an appropriation of \$444,698.00 from  
18 unspent part-time dollars within the Kids Hope Alliance  
19 Preteens and Teen Essential Services Category into the  
20 Kids Hope Alliance Out-of-School Time Essential Services  
21 Category.

22 **Section 2. Purpose.** The purpose of this ordinance is to  
23 authorize Kids Hope Alliance to provide direct funding in the  
24 amount of \$631,018.00 to the Jacksonville Alliance for Kipp  
25 Schools, Inc. to allow enhanced Services to be provided to at-hope  
26 children and youth in Jacksonville and to allow Kids Hope Alliance  
27 to transfer unspent part-time dollars within the Kids Hope Alliance  
28 Preteens and Teen Essential Services Category into the Kids Hope  
29 Alliance Out-of-School Time Essential Services Category as shown on  
30 the Second Revised 2019-511-E Schedule M, a copy of which is  
31 attached hereto as **Exhibit 2**.

1           **Section 3. Invoking the exception to Section 126.107(g),**  
2 **Ordinance Code.** The Kids Hope Alliance is hereby authorized to  
3 procure children's services from the Jacksonville Alliance for Kipp  
4 Schools, Inc. Pursuant to Section 126.107(g) (Exemptions), Part 1  
5 (General Regulations), Chapter 126 (Procurement Code), *Ordinance*  
6 *Code*, such services are exempted from competitive solicitation  
7 because the children's services to be provided are being  
8 appropriated and approved in this authorizing legislation.

9           **Section 4. Approval and authorization to execute.** The  
10 Mayor, or his designee, the Corporation Secretary, and/or the Chief  
11 Executive Officer of the Kids Hope Alliance ("CEO") are hereby  
12 authorized to execute a contract with the Jacksonville Alliance for  
13 Kipp Schools, Inc.

14           **Section 5. Waiver of the provisions in Chapter 77 (Kids**  
15 **Hope Alliance), Section 77.111(a) (Provider Contracts).** The City  
16 hereby waives the provisions in Chapter 77 (Kids Hope Alliance),  
17 Section 77.111(a) (Provider Contracts) with respect to the contracts  
18 approved and authorized under Section 3 of this Ordinance. Section  
19 77.111(a) requires contracts for children's services to be  
20 competitively procured by Kids Hope Alliance via an evaluated bid  
21 process. The waiver is needed in order to allow the Kids Hope  
22 Alliance to continue to support these children's services that were  
23 not eligible to be included in Kids Hope Alliance's most recent  
24 Request for Proposal for out-of-school time programming due to the  
25 unique nature of the model used by the Jacksonville Alliance for  
26 Kipp Schools, Inc.

27           **Section 6. Effective Date.** This ordinance shall become  
28 effective upon signature by the Mayor or upon becoming effective  
29 without the Mayor's signature.
