## NCSPHS AMENDMENT

The Neighborhoods, Community Services, Public Health and Safety Committee offers the following amendment to File No. 2020-328:

- (1) On page 1, line 5, after "AND" <u>insert</u> "APPROPRIATING \$16,548,162.10 IN CARES ACT FUNDS PLACED IN A CONTINGENCY ACCOUNT TO BE PLACED IN THE SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT TO BE USED FOR BUSINESS RELIEF GRANTS TO THOSE BUSINESSES WHO SUFFERED NEGATIVE IMPACTS DUE TO COVID-19;";
- (2) On page 1, line 9, <u>strike</u> "EXHIBIT 1" and <u>insert</u> "REVISED EXHIBIT 1";
- (3) On page 1, line 16, after "MEASURES;" <u>insert</u> "AUTHORIZING THE CITY TO ENTER INTO GRANT AGREEMENTS WITH RECIPIENTS;";
- (4) On page 2, line 22, and page 4, lines 13 and 17, <u>strike</u> "Exhibit 1" and <u>insert</u> "Revised Exhibit 1, labeled as "Revised Exhibit 1, Revised Grant List, June 15, 2020 -NCSPHS"";
- (5) On page 2, line 25, after "County" <u>insert</u> ", to partially reimburse costs of business interruption";
- (6) On page 3, line 11, <u>strike</u> "COVID-19." <u>insert</u> "COVID-19 and are necessary expenditures incurred due to the public health emergency with respect to COVID-19.";
- (7) On page 4, line 9<sup>1</sup>/<sub>2</sub>, <u>insert</u> new Sections 2 and 3 to read as follows:

"Section 2. Appropriation. For the 2019-2020 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b): (The account information is attached hereto as **Exhibit 2**  and incorporated herein by this reference)

## (C) **Explanation of Appropriation:**

The funding above is from CARES Act funds placed in a Contingency account to be placed in the Subsidies and Contributions to Private Organizations account to be used for business relief grants to those businesses who suffered negative impacts due to COVID-19.

Section 3. Purpose. The purpose of the appropriation in Section 2 is to provide funding to be used for business relief grants to those businesses who suffered negative impacts due to COVID-19 as identified in Revised Exhibit 1, labeled as "Revised Exhibit 1, Revised List, June 15, 2020 - NCSPHS."";

- (8) Renumber remaining Sections accordingly;
- (9) On page 4, line 12, after "businesses" insert "(collectively, the "Grant Recipients")";
- (10) On page 4, line 14<sup>1</sup>/<sub>2</sub>, <u>insert</u> a new Section 4 to read as follows:

"Section 4. Agreement approved and execution authorized. There is hereby approved, and the Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, grant agreements between the City of Jacksonville and the Grant Recipients in substantially the form attached hereto as **Exhibit 3**. Each Agreement provides for Cares Act grands funds in such amounts as set forth in **Revised Exhibit 1**, labeled as "Revised Exhibit 1, Revised List, June 15, 2020 – NCSPHS."

The Agreements may include such additions, deletions and changes as may be reasonable, necessary and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, or his designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor, or his designee; provided however, no modification to the Agreement may increase the financial obligations or liability of the City to an amount in excess of the amount stated in the Agreement or decrease the duties and obligations of the Grant Recipients as stated in the Agreement, and any such modification shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel. For the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City and any other non-substantive changes do not substantively increase the duties that and responsibilities of the City under the provisions of the Agreement, including any amendments deemed necessary to comply with Federal law applicable to the grant funds authorized by the Agreements.";

- (11) Renumber remaining Sections accordingly;
- (12) Remove Exhibit 1 and replace with Revised Exhibit 1 attached hereto, which attaches the Revised Grant Recipient List;
- (13) Attach Exhibit 2 attached hereto, which attaches the Account Information;
- (14) Attach Exhibit 3 attached hereto, which attaches the Grant
  Form Agreement template;
- (15) On **page 1**, **line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
