**Bill Summary:** The bill approves an initial Certificate of Public Convenience and Necessity (CON) for Hrustic Brothers, Inc. based on the Council's findings that the facility would serve the public convenience and provide a needed service to the citizens of Duval County. The bill provides conditions of the CON with thirty-one (31) specific conditions outlined in Exhibit 1. The following documents are filed with Legislative Services as exhibits:

- Exhibit 1 Hrustic Brothers, Inc. 139 Edgewood Avenue South Clean Debris Recycling Facility Certificate of Public Convenience and Necessity Specific Operating Conditions

**Background Information:** In accordance with Chapter 380, Part 1 Ordinance Code, Hrustic Brothers, Inc. has applied for an initial CON for the operation of a clean debris recycling facility proposed to be located at 139 Edgewood Avenue South, Jacksonville, Florida. The application has been reviewed by the Public Works Department, the Solid Waste Division, the Environmental Quality Division, the Planning and Development Department and the Florida Department of Health in Duval County and the applicant requirements for operation of such a facility have been met. Final approval of a CON facility is based upon the determination of need for this facility by the City Council. The proposed Hrustic Brothers, Inc. clean debris recycling facility is a private facility and the operation of the facility will not require any City of Jacksonville funding. Clean Debris (mainly concrete) recycling is beneficial to Duval County's recycling goals and recycled (crushed) concrete is commonly utilized in various aspects of construction projects.

Policy Impact Area: Public waste management; concrete, debris and recycling

**Fiscal Impact:** There is no City funding involved for this legislation. The facility is required to maintain financial assurance for cleanup activities required if the site is abandoned or is in violation of its CON.
