**BE IT ORDAINED** by the Council of the City of Jacksonville:

17 Section 1. Closure and Abandonment. The right-of-way of Pic-to-Yone Street, adopted as a county road by Resolution dated 18 19 March 30, 1949, and recorded in Deed Book 251, Page 424, and Deed 20 Book 253, Page 362 of the Current Public Records of Duval County, 21 Florida, in Council District 1, descriptions of which are attached 22 hereto as **Exhibit 1** and incorporated herein by this reference, is 23 hereby closed and abandoned and/or disclaimed as a right-of-way at the request of Jerry Nackashi, the principal of WPND, LLC and of 24 WPND No. 2 (the "Applicant"). 25

Section 2. Purpose. The Applicant owns both sides of the closure area and is requesting the closure to consolidate the two business properties. The Applicant has paid a closure application fee of \$2,091.00. There were no objections from any city, state, or utility agency to the closure. 1 Section 3. Hold Harmless Covenant. The closure and 2 abandonment by the City of its interest in the right-of-way is 3 subject to the execution and delivery to the City by Applicant of a hold harmless covenant in substantially the same form attached 4 hereto as **Exhibit 2** and incorporated herein by this reference. 5 Accordingly, the closure and abandonment of the right-of-way shall 6 7 not be recorded in the Public Records until execution and delivery to the City by the Applicant of the required hold harmless 8 9 covenant.

Section 4. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
