Section 4. Direction to send Ordinance to the Planning and Development Department. The Chief of Legislative Services is hereby directed to forward a copy of this legislation upon enactment to the Planning and Development Department for information and coordination on Land Use and Zoning public hearings.

Section 5. Council Rule 2.201 (Meetings) Waived. Pursuant to Council Rule 2.201 (Meetings), the Council President has set the regular meetings of the Land Use and Zoning Committee for the first and third Tuesdays of each month (except for the first week in July

and the third week in December). Council Rule 2.201 (Meetings) is hereby waived to authorize the rescheduling of the Finance, Rules and Land Use and Zoning Committee meetings as stated herein.
