5 AN ORDINANCE RESCHEDULING THE FINANCE, RULES
6 AND LAND USE AND ZONING COMMITTEE MEETINGS OF
7 TUESDAY, AUGUST 18, 2020, TO WEDNESDAY, AUGUST
8 19, 2020 AND THE MEETINGS OF TUESDAY, NOVEMBER
9 3, 2020 TO WEDNESDAY, NOVEMBER 4, 2020;
10 DIRECTING APPROPRIATE NOTIFICATION BY THE
11 CHIEF OF LEGISLATIVE SERVICES; DIRECTING
12 LEGISLATIVE SERVICES TO FORWARD THIS
13 LEGISLATION UPON ENACTMENT TO THE PLANNING AND
14 DEVELOPMENT DEPARTMENT FOR INFORMATION AND
15 COORDINATION ON LAND USE AND ZONING PUBLIC
16 HEARINGS; WAIVING COUNCIL RULE 2.201
17 (MEETINGS) IN ORDER TO AUTHORIZE THE
18 RESCHEDULING; REQUESTING EMERGENCY PASSAGE
19 UPON INTRODUCTION; PROVIDING AN EFFECTIVE
20 DATE.

22 **WHEREAS**, Council Rule 2.201 (Meetings) provides for Standing
23 Committee meetings to be held during the first and third weeks of
24 every month (except for the first week in July and the third week
25 in December), and pursuant to Council Rule 2.201 (Meetings), the
26 Council President has set the regular meetings of the Land Use and
27 Zoning Committee for the first and third Tuesdays of each month
28 (except for the first week in July and the third week in December);
29 and

30 **WHEREAS**, the Finance, Rules and Land Use and Zoning Committees
31 are scheduled to meet on Tuesday, August 18, 2020 and Tuesday,
32 November 3, 2020, which are the dates of the 2020 Primary Election

1 and the 2020 General Election respectively; now therefore

2 **BE IT ORDAINED** by the Council of the City of Jacksonville:

3 **Section 1. Committee meetings on Tuesday, August 18, 2020**
4 **rescheduled to Wednesday, August 19, 2020.** The Finance, Rules and
5 Land Use and Zoning Committee meetings scheduled for August 18,
6 2020, are hereby rescheduled to Wednesday, August 19, 2020. The
7 Finance, Rules and Land Use and Zoning Agenda meetings are also
8 hereby rescheduled respectively to Wednesday, August 19, 2020.

9 **Section 2. Committee meetings on Tuesday, November 3,**
10 **2020 rescheduled to Wednesday, November 4, 2020.** The Finance,
11 Rules and Land Use and Zoning Committee meetings scheduled for
12 November 3, 2020 are hereby rescheduled to Wednesday, November 4,
13 2020. The Finance, Rules and Land Use and Zoning Agenda meetings
14 are also hereby rescheduled respectively to Wednesday, November 4,
15 2020.

16 **Section 3. Notification.** The Chief of Legislative
17 Services is hereby directed to ensure that all public hearings are
18 advertised and scheduled for Wednesday, August 19, 2020 and
19 Wednesday, November 4, 2020, and to ensure that any other
20 notifications necessary to conduct the Finance, Rules and Land Use
21 and Zoning Committee meetings on Wednesday, August 19, 2020 and
22 Wednesday, November 4, 2020, are made.

23 **Section 4. Direction to send Ordinance to the Planning**
24 **and Development Department.** The Chief of Legislative Services is
25 hereby directed to forward a copy of this legislation upon
26 enactment to the Planning and Development Department for
27 information and coordination on Land Use and Zoning public
28 hearings.

29 **Section 5. Council Rule 2.201 (Meetings) Waived.** Pursuant
30 to Council Rule 2.201 (Meetings), the Council President has set the
31 regular meetings of the Land Use and Zoning Committee for the first
32 and third Tuesdays of each month (except for the first week in July

1 and the third week in December). Council Rule 2.201 (Meetings) is
2 hereby waived to authorize the rescheduling of the Finance, Rules
3 and Land Use and Zoning Committee meetings as stated herein.

4 **Section 6. Requesting Emergency Passage Upon Introduction**
5 **pursuant to Council Rule 4.901.** Emergency passage of this
6 legislation is requested upon introduction. The nature of the
7 emergency is that bills filed by the next filing deadline will be
8 scheduled for public hearings before the Land Use and Zoning
9 Committee during the third week in August and the first week of
10 November, and all notices and advertisements must be updated
11 accordingly.

12 **Section 7. Effective Date.** This ordinance shall
13 become effective upon signature by the Mayor or upon becoming
14 effective without the Mayor's signature.
