6 A RESOLUTION CONFIRMING THE APPOINTMENT OF
7 ANGELA STRAIN AS A MEMBER OF THE CULTURAL
8 SERVICE GRANT PROGRAM COMMITTEE, REPLACING
9 DAVID FALISZEK, AS ONE OF SEVEN COMMUNITY
10 REPRESENTATIVES, PURSUANT TO SECTION 118.605,
11 *ORDINANCE CODE*, FOR A FIRST TERM ENDING
12 DECEMBER 31, 2022; PROVIDING AN EFFECTIVE
13 DATE.

15 **WHEREAS**, pursuant to §118.605(a), *Ordinance Code*, the
16 membership of the Cultural Service Grant Program Committee shall be
17 comprised of 10 members (3 Cultural Council Board Members and 7
18 individuals from the community appointed by the Cultural Council
19 Board President, Cultural Service Grant Program Committee Chair,
20 and the 3 Cultural Council Board Members); and

21 **WHEREAS**, pursuant to §118.605(e), *Ordinance Code*, all members
22 of the Cultural Service Grant Program Committee shall be confirmed
23 by the City Council; and

24 **WHEREAS**, 2018-199-A appointed David Faliszek to the Cultural
25 Service Grant Program Committee with a term ending December 31,
26 2019 as a community representative; and

27 **WHEREAS**, the Cultural Council Board would like to amend
28 Faliszek's category of community representative to the Cultural
29 Council of Greater Jacksonville Board Member representative with a
30 term end date of December 31, 2020; and

31 **WHEREAS**, Resolution 2020-398 has been introduced to reappoint

1 Mr. Faliszek to the Cultural Service Grant Program Committee as a
2 Cultural Council of Greater Jacksonville Board Member
3 representative, leaving the Community representative seat open; now
4 therefore

5 **BE IT RESOLVED** by the Council of the City of Jacksonville:

6 **Section 1. Confirmation.** The Council hereby confirms the
7 appointment of Angela Strain, a Duval County resident, to the
8 Cultural Service Grant Program Committee, replacing David Faliszek,
9 as a community representative, in accordance with Sec. 118.605,
10 *Ordinance Code*, for a first term expiring December 31, 2022.

11 **Section 2. Effective Date.** This resolution shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
