6 AN ORDINANCE APPROVING A CHANGE IN THE POLLING  
7 PLACE LOCATION FOR PRECINCTS 201, 302, 310,  
8 607, 711, 713, 1101, 1104, 1110, AND 1115, TO  
9 BE EFFECTIVE STARTING FOR THE AUGUST 18, 2020  
10 PRIMARY ELECTION, IN THE CITY OF JACKSONVILLE,  
11 DUVAL COUNTY, FLORIDA, AS REQUESTED BY THE  
12 SUPERVISOR OF ELECTIONS PURSUANT TO SECTION  
13 352.102, *ORDINANCE CODE*; REQUESTING ONE CYCLE  
14 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE  
15 DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Precinct Location Change Approved.** At the  
19 request of the Supervisor of Elections for Duval County, and  
20 pursuant to Section 352.102, *Ordinance Code*, the Council, acting as  
21 the governing body for Duval County, hereby approves the polling  
22 place location changes in precincts 201, 302, 310, 607, 711, 713,  
23 1101, 1104, 1110, and 1115, as listed in **Revised Exhibit 1**,  
24 labeled as "Revised Exhibit 1, Rev List, July 21, 2020 - Rules"  
25 attached hereto, to be effective immediately for all special,  
26 primary and general elections conducted after passage. The  
27 Supervisor of Elections and the Council Secretary are hereby  
28 authorized and directed to include this precinct and polling place  
29 location in the Polling Place List on file in their respective  
30 offices.

31 **Section 2. Rule 4.901 Requesting One Cycle Emergency**

1 **Passage.** One cycle emergency passage of this legislation is  
2 requested. The nature of the emergency is that it is necessary to  
3 approve the polling locations changes as soon as possible to ensure  
4 that all of the changes are made in time for the August Primary  
5 Election.

6 **Section 3. Effective Date.** This Ordinance shall become  
7 effective upon signature by the Mayor or upon becoming effective  
8 without the Mayor's signature.
