4 **ORDINANCE 2020-366-E**

5 AN ORDINANCE APPROPRIATING A \$820,847.25 GRANT  
6 FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY,  
7 FUNDED THROUGH THE HAZARD MITIGATION GRANT  
8 PROGRAM AND APPROVED BY THE FLORIDA DIVISION  
9 OF EMERGENCY MANAGEMENT, AS INITIATED BY B.T.  
10 20-077; APPROVING AND AUTHORIZING THE MAYOR,  
11 OR HIS DESIGNEE, AND THE CORPORATION SECRETARY  
12 TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF  
13 THE CITY, THE HAZARD MITIGATION GRANT PROGRAM  
14 CONTRACT NUMBER H0434 BETWEEN THE CITY OF  
15 JACKSONVILLE AND THE FLORIDA DIVISION OF  
16 EMERGENCY MANAGEMENT; PROVIDING FOR OVERSIGHT  
17 BY THE PUBLIC BUILDINGS DIVISION OF THE CITY'S  
18 DEPARTMENT OF PUBLIC WORKS; AMENDING THE 2020-  
19 2024 FIVE-YEAR CAPITAL IMPROVEMENT PROGRAM  
20 APPROVED BY ORDINANCE 2019-505-E TO PROVIDE  
21 FUNDING FOR THE PROJECT ENTITLED "POLICE  
22 MEMORIAL BUILDING GENERATOR REPLACEMENT";  
23 PROVIDING AN EFFECTIVE DATE.

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2019-2020 fiscal year,  
27 within the City's budget, there are hereby appropriated the  
28 indicated sum(s) from the account(s) listed in subsection (a) to  
29 the account(s) listed in subsection (b):

5 (c) Explanation of Appropriation

6 The funding above is a grant from the Federal Emergency  
7 Management Agency, funded through the Hazard Mitigation  
8 Grant Program and approved by the Florida Division of  
9 Emergency Management.

10 **Section 2. Purpose.** The purpose of the appropriation in  
11 Section 1 is to provide funding for the purchase and installation  
12 of a permanent generator at the Police Memorial Building. The  
13 purchase and installation of a permanent generator will reduce  
14 and/or mitigate the damage that might occur as the result of severe  
15 weather or other hazards.

16 **Section 3. Approval and authorization.** There is hereby  
17 approved, and the Mayor, or his designee, and the Corporation  
18 Secretary are hereby authorized to execute and deliver, for and on  
19 behalf of the City, the Hazard Mitigation Grant Program Contract  
20 Number H0434 between the City of Jacksonville and the Florida  
21 Division of Emergency Management, a copy of which has been placed  
22 **ON FILE** with the Office of Legislative Services.

23 **Section 4. Oversight.** The Public Buildings Division  
24 of the Department of Public Works shall oversee the project  
25 described herein.

26 **Section 5. CIP Amendment.** Ordinance 2019-505-E, being  
27 the 2020-2024 Five-Year Capital Improvement Program for the City  
28 and certain of its independent agencies, is hereby amended to  
29 provide funding for the project entitled "Police Memorial Building  
30 Generator Replacement." The project is more fully described in the  
31 Project Information Sheet, attached hereto as **Exhibit 2** and

1 incorporated herein by this reference. The Council finds that the  
2 deferral of this amendment of the CIP until the next annual budget  
3 and CIP review will be detrimental to the best interests of the  
4 community because such deferral will result in the City's loss of  
5 needed grant dollars. Pursuant to Section 122.605(c), *Ordinance*  
6 *Code*, enactment of this ordinance requires the affirmative vote of  
7 two-thirds of the Council members present at the meeting because of  
8 the CIP amendment set forth in this section. This ordinance shall  
9 constitute an amendment to Ordinance 2019-505-E. In all other  
10 respects, the Five-Year Capital Improvement Program approved by  
11 Ordinance 2019-505-E shall continue in full force and effect.

12 **Section 6. Effective Date.** This ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
