In addition to the attached standard conditions, the above-referenced grant project is subject to the special conditions set forth below.

Ref# S41673: WITHHOLDING CONDITION: Prior to the obligation and drawdown of funds for the license plate readers (LPRs), the subgrantee must receive US Department of Justice approval of the National Environmental Protection Agency (NEPA) Exclusion Checklist submitted to the Office of Criminal Justice Grants.

Ref# S42658: The subgrantee's procurement policy does not appear to comply with all federal procurement requirements outlined in the Office of Management and Budget (OMB) Uniform Requirements, specifically: verifying suspension and debarment (200.318(h)), and prohibiting geographical preference (200.319(b)). All subaward procurements must comply with the standards identified in OMB's Uniform Requirements and documentation must be maintained and provided to the Office of Criminal Justice Grants at monitoring.

Ref# S42659: The subgrantee's inventory policy does not appear to comply with all federal procurement requirements outlined in the Office of Management and Budget (OMB) Uniform Requirements, specifically: 2 CFR 200.313(d)(1), including identifying with whom the title vests and stating the federal share of the property cost. Inventory of all subaward equipment must comply with the standards identified in OMB's Uniform Requirements and documentation must be maintained and provided to the Office of Criminal Justice Grants at monitoring.

Ref# S42660: At the time of application approval, the subgrantee's current EEO Plan (Utilization Report) and approval is expired. These documents must be updated and provided to the Office of Criminal Justice Grants at monitoring.

Ref# S42661: WITHHOLDING CONDITION: Prior to the obligation and drawdown of funds for the license plate readers (LPRs), the subgrantee must receive US Department of Justice approval for the sole source procurement in excess of the federal acquisition threshold (\$ 250,000).

Ref# S42662: Although federal regulations require a three year retention period on all grant records, the State of Florida General Records Schedule GS1-SL for state and local agencies, which is more stringent, requires subgrant recipients to maintain all records and documents for a minimum of five (5) years from the date of the final financial statement and be available for review upon request.
