6 AN ORDINANCE RESCHEDULING THE FINANCE, RULES  
7 AND LAND USE AND ZONING COMMITTEE MEETINGS OF  
8 NOVEMBER 3, 2020 TO WEDNESDAY, NOVEMBER 4,  
9 2020; DIRECTING APPROPRIATE NOTIFICATION BY  
10 THE CHIEF OF LEGISLATIVE SERVICES; DIRECTING  
11 LEGISLATIVE SERVICES TO FORWARD THIS  
12 LEGISLATION UPON ENACTMENT TO THE PLANNING AND  
13 DEVELOPMENT DEPARTMENT FOR INFORMATION AND  
14 COORDINATION ON LAND USE AND ZONING PUBLIC  
15 HEARINGS; WAIVING COUNCIL RULE 2.201  
16 (MEETINGS) IN ORDER TO AUTHORIZE THE  
17 RESCHEDULING; PROVIDING AN EFFECTIVE DATE.

19 **WHEREAS**, Council Rule 2.201 (Meetings) provides for Standing  
20 Committee meetings to be held during the first and third weeks of  
21 every month (except for the first week in July and the third week  
22 in December), and pursuant to Council Rule 2.201 (Meetings), the  
23 Council President has set the regular meetings of the Land Use and  
24 Zoning Committee for the first and third Tuesdays of each month  
25 (except for the first week in July and the third week in December);  
26 and

27 **WHEREAS**, the Finance, Rules and Land Use and Zoning Committees  
28 are scheduled to meet on Tuesday, November 3, 2020, which is the  
29 date of the 2020 General Election; now therefore

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1           **Section 1.       Committee meetings on Tuesday, November 3,**  
2 **2020 rescheduled to Wednesday, November 4, 2020.**     The Finance,  
3 Rules and Land Use and Zoning Committee meetings scheduled for  
4 November 3, 2020 are hereby rescheduled to Wednesday, November 4,  
5 2020. The Finance, Rules and Land Use and Zoning Agenda meetings  
6 are also hereby rescheduled respectively to Wednesday, November 4,  
7 2020.

8           **Section 2.       Notification.**           The Chief of Legislative  
9 Services is hereby directed to ensure that all public hearings are  
10 advertised and scheduled for Wednesday, November 4, 2020, and to  
11 ensure that any other notifications necessary to conduct the  
12 Finance, Rules and Land Use and Zoning Committee meetings on  
13 Wednesday, November 4, 2020, are made.

14          **Section 3.       Direction to send Ordinance to the Planning**  
15 **and Development Department.**   The Chief of Legislative Services is  
16 hereby directed to forward a copy of this legislation upon  
17 enactment to the Planning and Development Department for  
18 information and coordination on Land Use and Zoning public  
19 hearings.

20          **Section 4.       Council Rule 2.201 (Meetings) Waived.** Pursuant  
21 to Council Rule 2.201 (Meetings), the Council President has set the  
22 regular meetings of the Land Use and Zoning Committee for the first  
23 and third Tuesdays of each month (except for the first week in July  
24 and the third week in December). Council Rule 2.201 (Meetings) is  
25 hereby waived to authorize the rescheduling of the Finance, Rules  
26 and Land Use and Zoning Committee meetings as stated herein.

27          **Section 5.       Effective Date.** This ordinance shall become  
28 effective upon signature by the Mayor or upon becoming effective  
29 without the Mayor's signature.
