8 (PREPARATION AND SUBMISSION OF THE CAPITAL  
9 IMPROVEMENT PLAN BUDGET AND CAPITAL  
10 IMPROVEMENT PLAN), PART 6 (CAPITAL IMPROVEMENT  
11 PLAN), CHAPTER 122 (PUBLIC PROPERTY),  
12 *ORDINANCE CODE*, TO PROVIDE FOR INPUT FROM EACH  
13 OF THE SIX CITIZEN PLANNING ADVISORY  
14 COMMITTEES WHEN DEVELOPING THE PROPOSED  
15 CAPITAL IMPROVEMENT PLAN; PROVIDING AN  
16 EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Amending Section 122.604 (Preparation and**  
20 **submission of the Capital Improvement Plan Budget and Capital**  
21 **Improvement Plan), Part 6 (Capital Improvement Plan), Chapter 122**  
22 **(Public Property), *Ordinance Code*.** Section 122.604 (Preparation and  
23 submission of the Capital Improvement Plan Budget and Capital  
24 Improvement Plan), Chapter 122 (Public Property), *Ordinance Code*,  
25 is hereby amended to read as follows:

26 **CHAPTER 122. PUBLIC PROPERTY**

28 **PART 6. CAPITAL IMPROVEMENT PLAN**

30 **Sec. 122.604. - Preparation and submission of the Capital**  
31 **Improvement Plan Budget and Capital Improvement Plan.**

1 On or before January 15 of each year, the Department of Finance  
2 and Administration, the Department of Planning and Development and  
3 the Department of Public Works shall meet with all departments,  
4 agencies and commissions of the City to develop a proposed Capital  
5 Improvement Plan Budget for the succeeding fiscal year and a  
6 proposed Capital Improvement Plan. Input from each of the six  
7 Citizen Planning Advisory Committees (CPACs) shall be requested  
8 and considered when developing the proposed Capital Improvement  
9 Plan. The proposed Capital Improvement Plan shall include a  
10 priority system developed by the Department of Finance and  
11 Administration. The Mayor shall submit the proposed Capital  
12 Improvement Plan Budget and the proposed Capital Improvement Plan  
13 to the City Council on or before July 15 of each year.

14 **Section 2. Effective Date.** This ordinance shall become  
15 effective upon signature by the Mayor or upon becoming effective  
16 without the Mayor's signature.
