4 **ORDINANCE 2020-420-E**

5 AN ORDINANCE CONFIRMING THE APPOINTMENT OF
6 COUNCIL MEMBER GARRETT DENNIS AS A DESIGNATED
7 MEMBER OF THE FLORIDA ASSOCIATION OF COUNTIES,
8 AS A FIRST TERM COUNCIL MEMBER, FOR A TERM
9 CONCURRENT WITH THE REMAINING YEARS OF HIS
10 FIRST ELECTED TERM OF OFFICE; WAIVING COUNCIL
11 RULE 1.306 (DESIGNATED LEAGUE OF CITIES AND
12 ASSOCIATION OF COUNTIES COUNCIL MEMBER
13 APPOINTMENTS), *COUNCIL RULES*, AS TO THE
14 REQUIREMENT THAT ONE COUNCIL MEMBER SHALL BE A
15 FIRST TERM COUNCIL MEMBER; PROVIDING AN
16 EFFECTIVE DATE.

18 **WHEREAS**, in order to fully participate and benefit from
19 membership in the Florida Association of Counties, Ordinance 2017-
20 97-E authorized two Council Members to attend the Florida
21 Association of Counties meetings; and

22 **WHEREAS**, Council Rule 1.306 provides that the City Council
23 President shall appoint a first term Council Member to serve on the
24 Florida Association of Counties; now therefore

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Confirmation.** The Council hereby confirms the
27 Council President's appointment of Council Member Garrett Dennis as
28 a designated member of the Florida Association of Counties, as a
29 first term council member, for a term concurrent with the remaining
30 years of his first elected term of office.

31 **Section 2. Waiver of Council Rule 1.306 (Designated**

1 **League of Cities and Association of Counties Council Member**
2 **Appointments), Council Rules.** Council Rule 1.306 (Designated League
3 of Cities and Association of Counties Council Member Appointments),
4 Part 3 (Members of Council), Chapter 1 (Organization of the
5 Council), is hereby waived as to the requirement that one Council
6 Member appointed to the Association of Counties shall be a first
7 term Council Member. A waiver of Council Rule 1.306 is needed
8 because both Council Members being appointed to the Association of
9 Counties are second term Council Members.

10 **Section 3. Effective Date.** This Ordinance shall become
11 effective upon adoption by the Council.
