## ORDINANCE 2020-401-E

AN ORDINANCE CLOSING AND ABANDONING AND/OR DISCLAIMING A PORTION OF PICKETT'S LANE, AN UNIMPROVED RIGHT-OF-WAY UNOPENED AND ESTABLISHED IN THE HOLMESDALE UNIT 2, RECORDED 21, PAGE 46, OF THE CURRENT IN PLAT BOOK PUBLIC RECORDS OF DUVAL COUNTY, FLORIDA, IN COUNCIL DISTRICT 8, AT THE REQUEST OF PAUL HARDEN, SUBJECT TO RESERVATION UNTO JEA OF AN UTILITIES EASEMENT OVER THE PICKETT'S LANE RIGHT-OF-WAY; PROVIDING FOR APPROVAL SUBJECT TO CONDITIONS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Closure and Abandonment. A portion of Pickett's Lane, an unopened and unimproved right-of-way established in the Holmesdale Unit 2, recorded in Plat Book 21, Page 46, of the Current Public Records of Duval County, Florida, in Council District 8, descriptions of which are attached hereto as Exhibit 1 and incorporated herein by this reference, is hereby closed and abandoned and/or disclaimed as a right-of-way at the request of Paul Harden, as agent for Emilio Montilla Investments, Inc. and VRV, LLC (the "Applicants"); provided, however, there is reserved unto JEA an All Utilities Easement on, over, across, and under the closed Pickett's Lane right-of-way.

Section 2. Purpose. The Applicants own both sides of the closure area and are requesting the closure to add additional

parking for their businesses. The Applicants have paid a closure application fee of \$2,091.00. There were no objections from any city, state, or utility agency to the closure.

Section 3. Hold Harmless Covenant. The closure and abandonment by the City of its interest in the right-of-way is subject to the execution and delivery to the City by Applicant of a hold harmless covenant in substantially the same form attached hereto as Exhibit 2 and incorporated herein by this reference. Accordingly, the closure and abandonment of the right-of-way shall not be recorded in the Public Records until execution and delivery to the City by the Applicants of the required hold harmless covenant.

Section 4. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
