7 AN ORDINANCE APPROPRIATING A \$20,000.00 GRANT
8 RECEIVED FROM THE CITIES FOR FINANCIAL
9 EMPOWERMENT FUND ("CFE") TO SUPPORT THE KIDS
10 HOPE ALLIANCE ("KHA") IN DEVELOPING DURING THE
11 PERIOD MAY 1, 2020 THROUGH APRIL 30, 2021 A
12 PLAN FOR INTEGRATING COMPREHENSIVE FINANCIAL
13 EDUCATION AND BANKING ACCESS INTO THE CITY OF
14 JACKSONVILLE'S 2021 SUMMER YOUTH EMPLOYMENT
15 PROGRAM, AS INITIATED BY REVISED B.T. 20-101;
16 PROVIDING AN EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
20 within the City's budget, there are hereby appropriated the
21 indicated sum(s) from the account(s) listed in subsection (a) to
22 the account(s) listed in subsection (b):

30 (c) Explanation of appropriation:

1 The funding above is a grant received from CFE to support
2 KHA in developing during the period May 1, 2020 through
3 April 30, 2021 a plan for integrating comprehensive
4 financial education and banking access into the City of
5 Jacksonville's 2021 Summer Youth Employment Program.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 this ordinance is to support KHA in developing during the period
8 May 1, 2020 through April 30, 2021 a plan for integrating
9 comprehensive financial education and banking access into the City
10 of Jacksonville's 2021 Summer Youth Employment Program. At least
11 1,000 youth are expected to be served in the City of Jacksonville's
12 2021 Summer Youth Employment Program. These youth will benefit from
13 financial education and banking access programming. The grant term
14 will run from May 1, 2020, through April 30, 2021. A copy of the
15 grant award letter is attached hereto as **Exhibit 2**.

16 **Section 3. Effective Date.** This ordinance shall become
17 effective upon signature by the Mayor or upon becoming effective
18 without the Mayor's signature.
