The provisions of Section 111.755 (Environmental Protection Fund), Part 7 (Environment and Conservation), Chapter 111 (Special Revenue and Trust Accounts), Ordinance Code, in conflict with this ordinance are hereby waived so as to authorize the EPB to use funds from the Fund for the purchase of equipment to be utilized for the Project. public hearing on August 19, 2019, the EPB determined that funding completion of the Project is a worthwhile and beneficial use of Fund dollars and such Code waivers necessary to allow for Project completion were approved by a unanimous vote of the EPB. A copy of the minutes of the EPB meeting of August 19, 2019, is attached hereto as Exhibit 2 and incorporated herein by this reference.

Section 5. Invoking the exception pursuant to Section 126.107(g), Ordinance Code. The City is hereby authorized to continue contracting with Jacksonville University for the purposes described in Section 2. Pursuant to Section 126.107(q) (Exemptions), Part 1 (General Regulations), Chapter (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.
