5 **ORDINANCE 2020-592**

6 AN ORDINANCE APPROVING THE ISLE OF PALMS
7 SPECIAL DISTRICT AMENDED FISCAL YEAR 2020-2021
8 BUDGET, PER ORDINANCE 2011-724-E AND SECTION
9 189.02, *FLORIDA STATUTES*; PROVIDING AN
10 EFFECTIVE DATE.

12 **WHEREAS**, the City of Jacksonville established the Isle of
13 Palms Special District (the "District"), per Ordinance 2011-724-E
14 and section 189.02, *Florida Statutes*, a dependent special district
15 for the purpose of dredging the Isle of Palms canal system; and

16 **WHEREAS**, in order for the District to qualify as a dependent
17 special district per section 189.02, *Florida Statutes*, the City, in
18 Ordinance 2011-724-E, required the District to submit its proposed
19 budget to the City Council every year by April 1st; and

20 **WHEREAS**, the District submitted its proposed Fiscal Year 2020-
21 2021 budget, which was approved by the City Council in Ordinance
22 2020-217-E, that set the non-ad valorem assessment per parcel at
23 \$950.00; and

24 **WHEREAS**, on September 9, 2020, the District adopted Resolution
25 20-03 which increased the non-ad valorem assessment to be levied on
26 property from \$950.00 per parcel to \$1,000.00 per parcel, and the
27 District adopted a modified Fiscal Year 2020-2021 budget through
28 Resolution 20-03; and

29 **WHEREAS**, the Isle of Palms Special District submitted the
30 amended Fiscal Year 2020/2021 budget to the City Council for
31 approval pursuant to Ordinance 2011-724-E, a copy of the Board

1 Resolution is attached hereto as **Exhibit 1**; and

2 **WHEREAS**, the City Council finds that the Isle of Palms Special
3 District amended Fiscal Year 2020/2021 budget in **Exhibit 1** should
4 be approved; now therefore

5 **BE IT ORDAINED** by the Council of the City of Jacksonville:

6 **Section 1. Approval of Isle of Palms Special District**
7 **Amended Fiscal Year 2020/2021 Budget.** The Isle of Palms Special
8 District amended Fiscal Year 2020/2021 budget, attached hereto as
9 **Exhibit 1**, is hereby approved.

10 **Section 2. Effective Date.** This ordinance shall become
11 effective upon signature by the Mayor, or upon becoming effective
12 without the Mayor's signature.
