ORDINANCE 2020-506-E

AN ORDINANCE AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO (1)EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY, (A)AN AGREEMENT WITH SHANDS JACKSONVILLE MEDICAL CENTER, INC., AND (B) A LETTER OF AGREEMENT WITH THE STATE OF FLORIDA THROUGH ITS AGENCY FOR HEALTH CARE ADMINISTRATION, BOTH CONCERNING PAYMENT DISTRIBUTION OF THE CITY'S INDIGENT HEALTH CARE FUNDS IN THE AMOUNT OF \$30,275,594 FOR FISCAL YEAR 2020-2021, AND (2) TAKE SUCH FURTHER ACTION AS MAY BENECESSARY APPROPRIATE TO EFFECTUATE THE PURPOSE OF THE ORDINANCE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Authorization. The Mayor, or his designee, and Corporation Secretary are hereby authorized to: (1) execute and deliver (a) an agreement between the City of Jacksonville and Shands Jacksonville Medical Center, Inc. ("Shands"), in substantially the same form as is attached hereto as Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Shands Agmt, September 15, 2020 - Finance" and incorporated herein by this reference, and (b) letters of Agreement between the City of Jacksonville and the State of Florida Agency for Health Care

Administration, in substantially the same form as is attached hereto as Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev LIP Agmt, September 15, 2020 - Finance" and Revised Exhibit 3, labeled as "Revised Exhibit 3, Rev DSH Agmt, September 15, 2020 - Finance" and incorporated herein by this reference, both of which concern payment and distribution of the City's indigent health care funds in the amount of \$30,275,594 for fiscal year 2020-2021 and, (2) take such further action as may be necessary or appropriate to effectuate the purpose of this ordinance. No agreements between the City and the State of Florida, Agency for Health Care Administration, will be executed and no funding disbursed by the City to the State until the City confirms adequate participation in the IGT program by other counties and government entities in the State.

Section 2. Purpose. The purpose of this Ordinance is to provide for the distribution of the City's contribution to indigent health care funding between Shands and the State of Florida as part of the State's Medicaid Hospital Program.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
