The appropriations made herein shall be awarded as grants-inaid to the miscellaneous agencies, and shall not require additional legislation for distribution of funds. Pursuant to Section 118.808, Ordinance Code, the Public Service Grant Council shall forward a complete list of the Public Service Grants recipients and funding allocation to the Council Auditor's office, the Office of the Mayor, the City Council and the Director of the Finance and Administration Department.

Section 3. Oversight Department. The Office of Grants and Contract Compliance of the Finance and Administration Department shall oversee the project described herein.

(Annual Lump Sum Appropriation for Public Service Grants), Ordinance Code. The conflicting provision of \$118.802 (Annual Lump Sum Appropriation for Public Service Grants), Ordinance Code, referring to "the annual budget ordinance" is hereby waived. Waiver of Section 118.802, Ordinance Code, is necessary because the Public Service Grant lump sum appropriation for the 2020-2021 annual budget will be considered by Council not in the annual budget Ordinance 2020-504, but rather in a separate Ordinance 2020-509.
