7 AN ORDINANCE APPROPRIATING \$991,592.00
8 (\$826,327.00 IN CORONAVIRUS AID, RELIEF, AND
9 ECONOMIC SECURITY (CARES) ACT GRANT FUNDING
10 FROM THE FEDERAL GOVERNMENT, AND \$165,265.00
11 FROM THE CITY'S GENERAL FUND (\$20,427 FROM
12 GENERAL FUND OPERATING RESERVES FOR FEDERAL
13 PROGRAMS AND A \$144,838 TRANSFER FROM GENERAL
14 FUND - GSD FUND BALANCE)) TO PREVENT, PREPARE
15 FOR, AND RESPOND TO THE CORONAVIRUS AS IT
16 AFFECTS THE 2020 FEDERAL ELECTIONS, AS
17 INITIATED BY B.T. 20-112; APPROVING AND
18 AUTHORIZING THE SUPERVISOR OF ELECTIONS TO
19 EXECUTE AND DELIVER ON BEHALF OF THE CITY THE
20 MEMORANDUM OF AGREEMENT FOR FEDERAL FUNDS -
21 CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY
22 (CARES) ACT BETWEEN THE STATE OF FLORIDA
23 DEPARTMENT OF STATE, DIVISION OF ELECTIONS AND
24 THE SUPERVISOR OF ELECTIONS FOR DUVAL COUNTY,
25 FLORIDA; PROVIDING FOR OVERSIGHT BY THE
26 SUPERVISOR OF ELECTIONS; REQUESTING ONE CYCLE
27 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE
28 DATE.

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
 2 within the City's budget, there are hereby appropriated the
 3 indicated sum(s) from the account(s) listed in subsection (a) to
 4 the account(s) listed in subsection (b):

11 (c) Explanation of Appropriation

12 The funding above is an appropriation of Coronavirus Aid,
 13 Relief, and Economic Security (CARES) Act grant funds in
 14 the amount of \$826,327.00, and an appropriation from the
 15 City's General Fund in the amount of \$165,265.00 (\$20,427
 16 from General Fund Operating Reserves for Federal Programs
 17 and a \$144,838 transfer from General Fund - GSD Fund
 18 Balance) to prevent, prepare for, and respond to the
 19 coronavirus pandemic as it affects the 2020 general
 20 election.

21 **Section 2. Purpose.** The purpose of the appropriation in
 22 Section 1 is to provide funds to be used to prevent, prepare
 23 for, and respond to the coronavirus pandemic as it affects the 2020
 24 general election.

25 **Section 3. Approval and authorization.** There is hereby
 26 approved, and the Supervisor of Elections is hereby authorized to
 27 execute and deliver on behalf of the City the Memorandum of
 28 Agreement for Federal Funds - Coronavirus Aid, Relief and Economic
 29 Security (CARES) Act between the State of Florida Department of
 30 State, Division of Elections and the Supervisor of Elections for
 31 Duval County, Florida, in substantially the same form placed **On**

1 **File** with the Office of Legislative Services.

2 **Section 4. Oversight.** The Supervisor of Elections
3 shall oversee the project.

4 **Section 5. Requesting one cycle emergency passage**
5 **pursuant to Council Rule 4.901 Emergency.** One cycle emergency
6 passage of this legislation is requested because of the time frame
7 of the upcoming general election.

8 **Section 6. Effective Date.** This ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
