6 AN ORDINANCE APPROPRIATING \$20,100.00 IN GRANT
7 FUNDING FROM THE U.S. DEPARTMENT OF
8 TRANSPORTATION FEDERAL RAILROAD ADMINISTRATION
9 ("FRA"), WITH NO LOCAL MATCH, FOR THE RAILROAD
10 TRESPASSING ENFORCEMENT PROGRAM WITHIN THE
11 CITY OF JACKSONVILLE SHERIFF'S OFFICE, AS
12 INITIATED BY B.T. 20-117; APPROVING AND
13 AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND
14 THE CORPORATION SECRETARY, TO EXECUTE AND
15 DELIVER ON BEHALF OF THE CITY THAT CERTAIN
16 GRANT AGREEMENT BETWEEN FRA AND THE CITY;
17 PROVIDING FOR CITY OVERSIGHT BY THE
18 JACKSONVILLE SHERIFF'S OFFICE, PATROL DIVISION;
19 PROVIDING AN EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
23 within the City's budget, there is hereby appropriated the
24 indicated sum(s) from the account(s) listed in subsection (a) to
25 the account(s) listed in subsection (b):

1 (c) Explanation of Appropriation

2 The funding above is a grant from the U.S. Department of
3 Transportation Federal Railroad Administration, with no
4 local match, for the Railroad Trespassing Enforcement
5 Program (the "Railroad Program") for the grant period
6 beginning September 1, 2020 to September 1, 2021.

7 **Section 2. Purpose.** The purpose of the appropriation in
8 Section 1 is to fund overtime costs for the deployment of patrol
9 officers along the federal railways of the City of Jacksonville to
10 conduct trespassing-related education and enforcement of the
11 Railroad Program.

12 **Section 3. Approval and Authorization.** There is hereby
13 approved, and the Mayor, or his designee, and the Corporation
14 Secretary are hereby authorized, to execute and deliver that
15 certain Grant Agreement between FRA and the City (the "Grant
16 Agreement"), a copy of which has been placed **On File** with the
17 Office of Legislative Services, and any extensions or amendments
18 thereto. The Grant Agreement does not require a City match.

19 **Section 4. Oversight.** The City of Jacksonville Sheriff's
20 Office, Patrol Division, shall oversee the Railroad Program
21 described herein.

22 **Section 5. Effective Date.** This Ordinance shall become
23 effective upon signature by the Mayor or upon becoming effective
24 without the Mayor's signature.
